1. The purchase from Guided Investments Limited of the part of Block B, Registered Plan 636 illustrated on the sketch attached as Schedule A hereto, at a purchase price of TWO HUNDRED AND SIXTY THOUSAND DOLLARS (\$260,000) per acre plus legal and survey costs is hereby authorized.
2. The Mayor and Clerk are hereby authorized to execute all documents approved by the City Solicitor that are necessary to effect the said purchase.

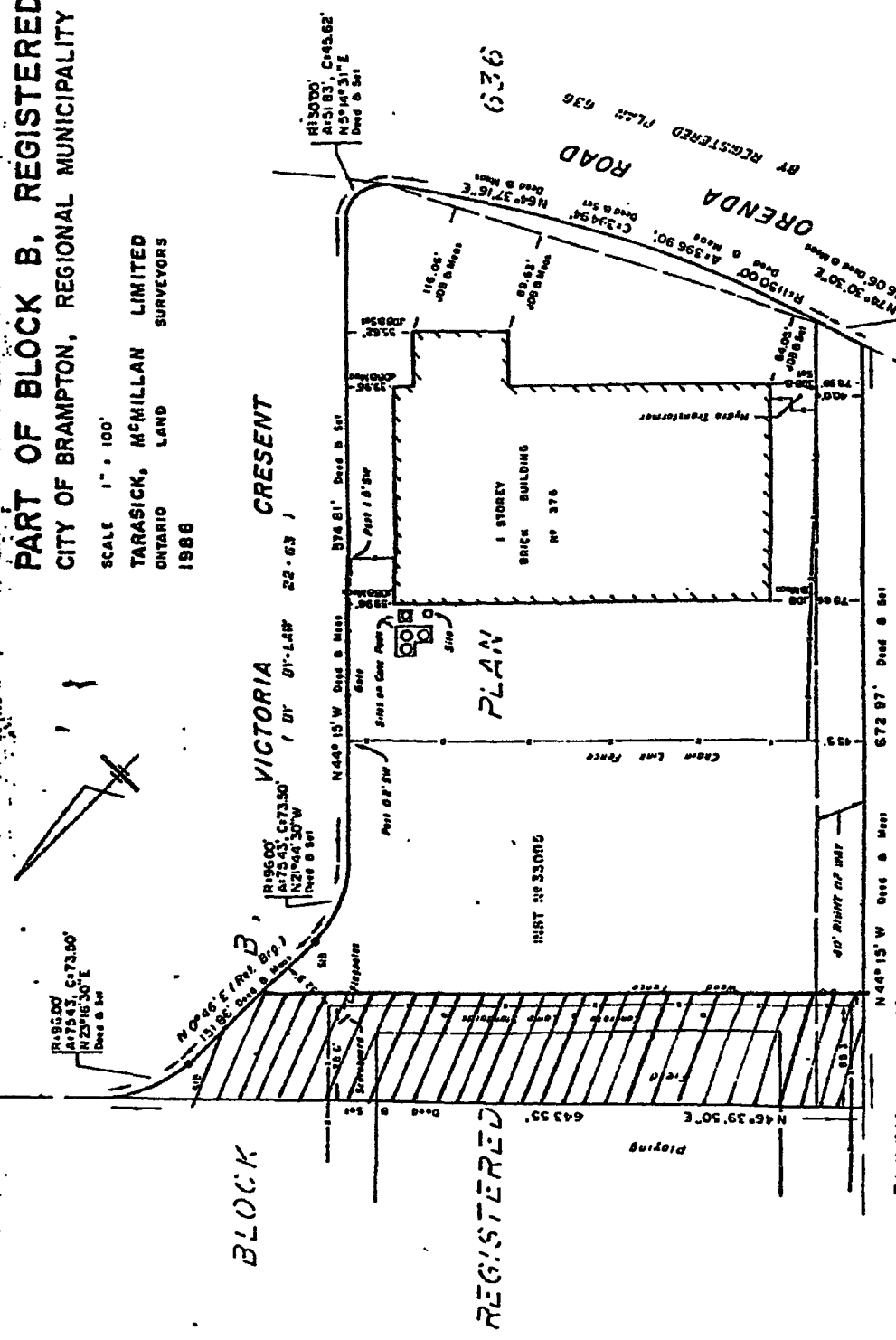
