BY-LAW

Number 173-85

To amend By-law 200-82 (part of Lot 6, Concession 2, W.H.S., geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

- (1) by changing the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE-FAMILY B (R1B) to COMMERCIAL THREE-SECTION 241 (C3-SECTION 241).
- (2) by deleting Sheet 3 of Schedule A thereto, and substituting therefor Schedule B to this by-law;
- (3) by adding thereto the following section:

"241. The lands designated C3-SECTION 241 on Schedule A to this by-law:

241.1 shall only be used for the parking of motor vehicles in connection with the use of the abutting lands to the east (zoned C3-SECTION 107).

241.2 shall be subject to the following requirement and restriction:

(a) the parking spaces on this parcel of land shall not be counted or included when calculating the number of parking spaces available for or in connection with a use on any abutting lands."

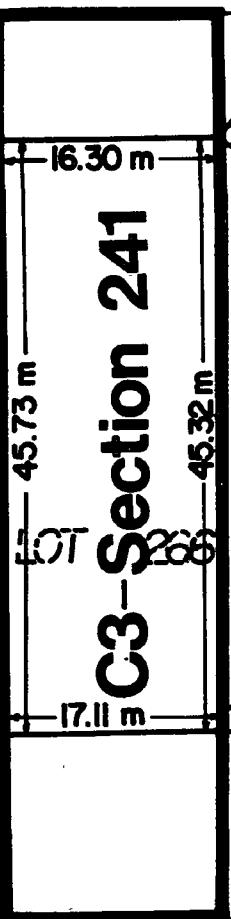

PART OF LOT 6, CON. 2, W.H.S.

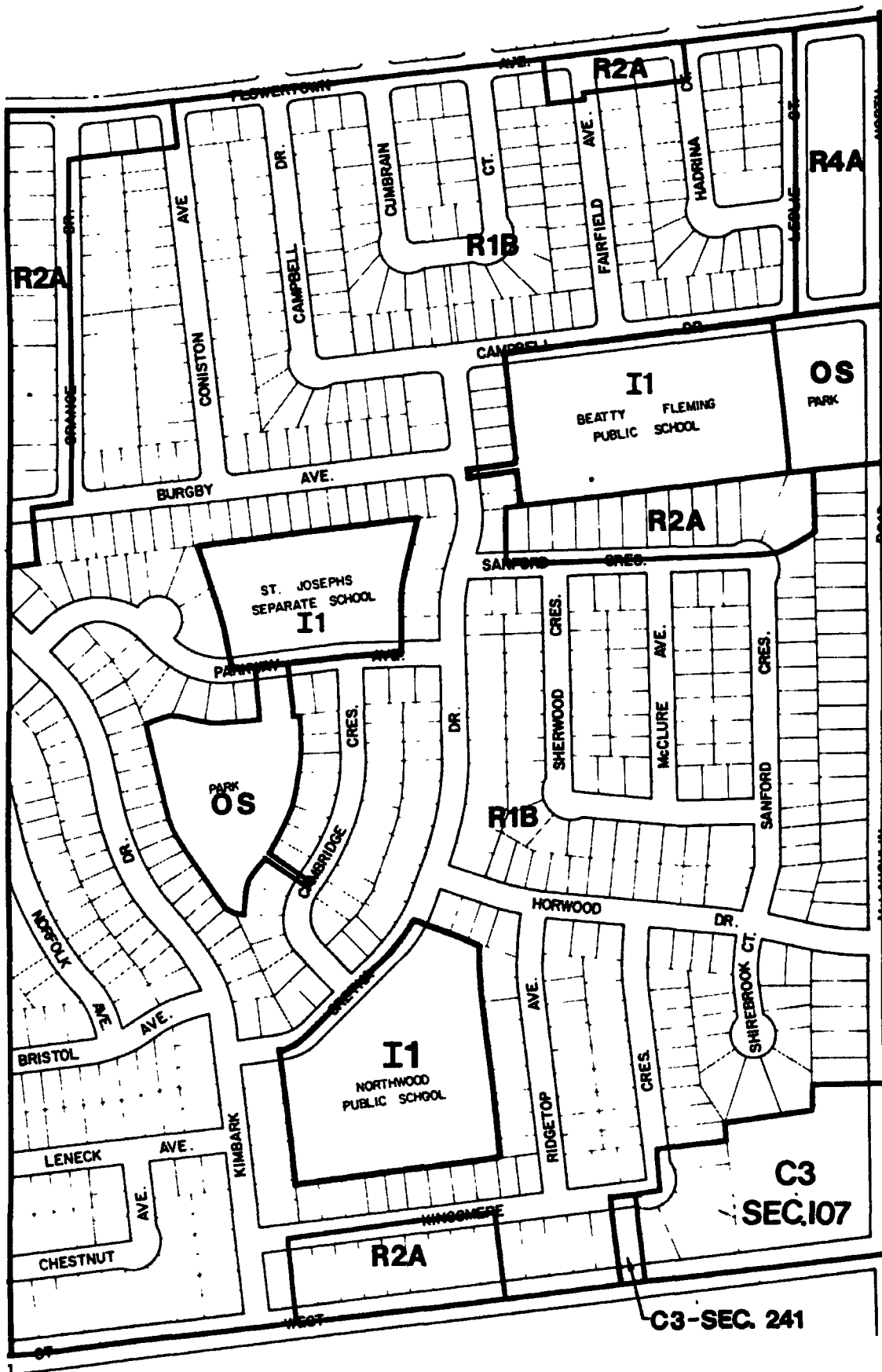
