To amend By-law 56-83 (Former Township of Toronto Gore Comprehensive Zoning By-law)

The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 56-83, as amended, is hereby further amended:
  - (1) by deleting therefrom section 10.3(a)(8), and substituting therefor the following:

"10.3(a)(8) shall not have vehicle garage doors which exceed 2.4 metres in height."

- (2) by deleting therefrom section 10.3(b)(10), and substituting therfor the following:
  - "10.3(b)(10) shall not have vehicle garage doors which exceed 2.4 metres in height."
- (3) by deleting therefrom section 10.4 and substituting therefor, the following:

## "10.4 Attached Garage or Carport

Where a garage or carport is attached to a dwelling unit on the lot on which it is located, it shall not be considered an accessory building, and shall comply with the yard and area requirements for the residential or agricultural zone, in which it is located, except that the front wall of any garage or carport shall not be located closer than 6.0 metres from the front lot line. Vehicle garage doors shall not exceed 2.4 metres in height." READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,
