BY-LAW

Number 178-90

To amend By-law 151-88, as amended
(part of Lot 7, Concession 6, E.H.S.,
geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

(1) by changing on Sheet 48B of Schedule A thereto the zoning designation of the land shown outlined on Schedule A to this by-law from INDUSTRIAL THREE SECTION 363 (M3-SEC.363) to INSTITUTIONAL ONE SECTION 559 (I1-SEC.559), such lands being part of Lot 7, Concession 6, East of Hurontario Street, in the geographic Township of Chinguacousy.

(2) by adding thereto the following section:

"559 The lands designated I1-SECTION 559 on Sheet 48B of Schedule A to this by-law:

559.1 shall only be used for the purposes permitted in an I1 zone;



559.2 shall also be subject to the following requirements and restrictions:

(1) A landscaped buffer area with a minimum width of 12.0 metres shall be provided and maintained adjacent to Torbram Road.

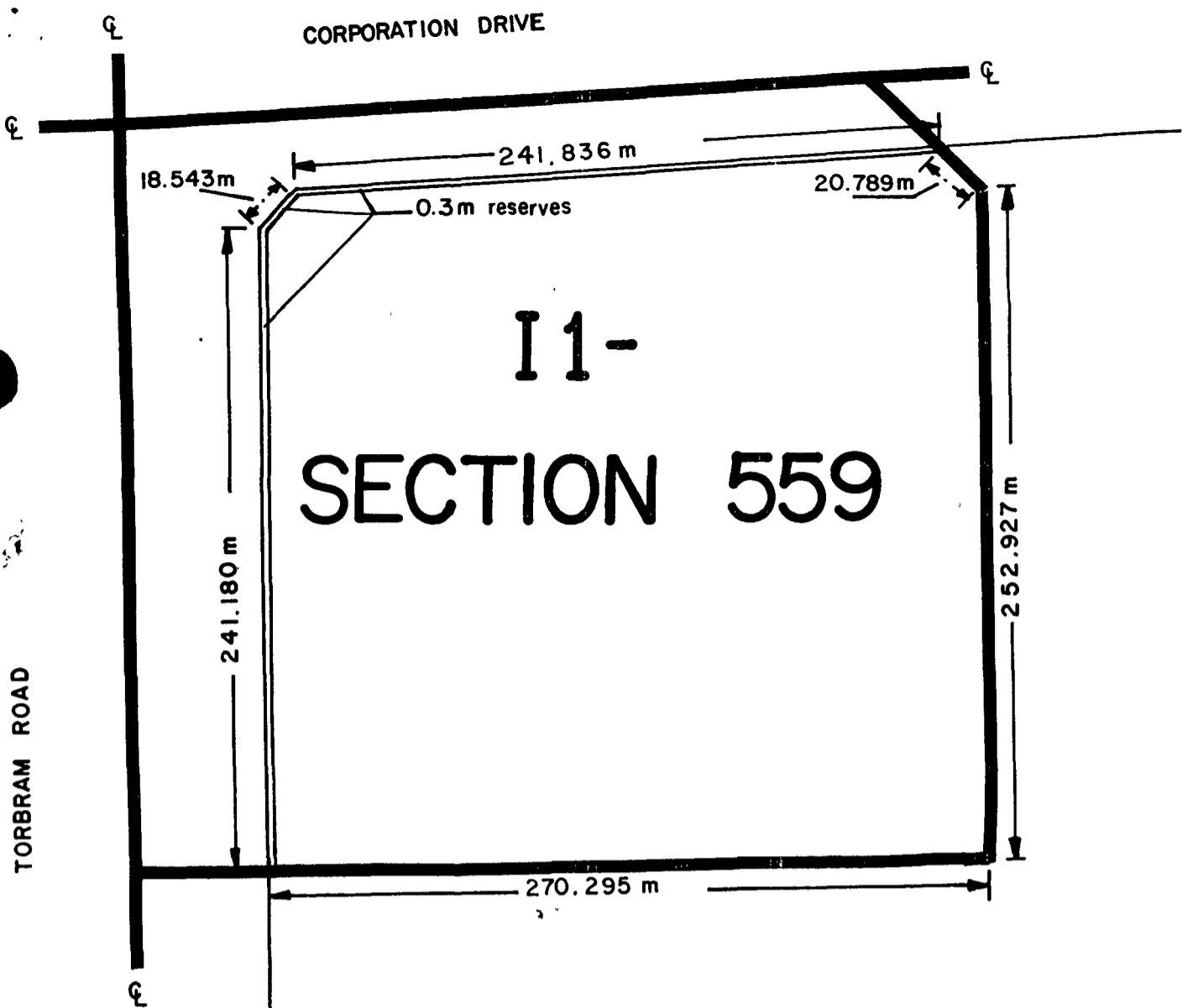
559.3 shall also be subject to the requirements and restrictions relating to the I1 zone and all general provisions of this by-law which are not in conflict with the ones set out in section 559.2."


