BY-LAW

Number 181-88

To amend By-law 63-87 (to regulate, supervise and govern the parking of vehicles on municipal parking lots)

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 63-87, as amended, is hereby further amended:
 - (1) by deleting from the specified columns of Schedule A thereto the following items:
