## **BY-LAW**

Number \_\_\_\_\_ 184-84 To establish certain lands as part of Kennedy Road South

WHEREAS the lands described in Schedule A hereto were conveyed to The Corporation of the Township of Toronto and The Corporation of the Town of Mississauga respectively;

AND WHEREAS the said lands became part of The Corporation of the City of Brampton by virtue of subsection 2(1)(b) of the <u>Regional Municipality of Peel Act</u> (R.S.O. 1980, chapter 440, as amended);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

APPROVED AS TO FORM The lands acquired by The Corporation of the Township of Toronto and described firstly and secondly in Schedule A hereto attached, and the lands acquired by The Corporation of the Town of Mississauga and described thirdly in Schedule A hereto attached, are hereby established as part of the public highway system of The Corporation of the City of Brampton.

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Township of Toronto, in the County of Peel), and being composed of part of Lot 12, Concession 2, East of Hurontario Street more particularly described as follows:

PREMISING that the southwestern limit of said Lot 12 has a bearing of North 44 degrees, 50 minutes West, and relating all bearings herein thereto;

COMMENCING at a standard iron bar marking the West angle of said lot;

THENCE South 44 degrees, 50 minutes East, along said southwestern limit 501.0 feet to the cut cross on a stone in the line of a post and wire fence running northeasterly;

THENCE North 38 degrees, 35 minutes, 30 seconds East, along said line of post and wire fence 27.18 feet to a standard iron bar therein;

THENCE North 44 degrees, 50 minutes West, parallel to said southwestern limit 501.0 feet to a standard iron bar in the northwestern limit of said lot as defined by the line of a post and wire fence;

THENCE South 38 degrees, 35 minutes, 30 seconds West, along said northwestern limit 27.18 feet, more or less, to the point of commencement.

PREMISING that the northeasterly limit of the road allowance between Concessions 1 and 2, East of Hurontario Street across Lot 13, as shown on Reference Plan 43R-2995 has a bearing of North 44 degrees, 12 minutes, 05 seconds West, and relating all bearings herein thereto;

COMMENCING at standard iron bar marking the intersection of the line between the northerly and the southerly halves of Lot 13, Concession 2, East of Hurontario Street, with the southwesterly limit of said Lot 13, point being the southerly corner of Part 5 on Reference Plan 43R-2995;

THENCE South 44 degrees, 12 minutes, 05 seconds East, along the southwesterly limit of said Lot 13, 110.89 feet to an iron bar;

THENCE North 39 degrees, 00 minutes, 25 seconds East, 27.19 feet, more or less, to a point, being 27.00 feet measurement at right angles to the southwesterly limit of said Lot 13;

THENCE South 39 degrees, 17 minutes, 45 seconds West, along the line between the northerly and southerly halves of said Lot 13, 27.17 feet, more or less, to the point of commencement.

THENCE South 46 degrees, 39 minutes, 20 seconds East, 113.63 feet, more or less, to a standard iron bar found planted in the northeasterly limit of the road allowance between Concessions One and Two, East of Hurontario Street as widened by Instrument Number 1704624 (Toronto) registered in the Land Registry Office for the Registry Division of Péel (No. 43);

THENCE North 60 degrees, 20 minutes, 10 seconds West, along the said widened limit 114.67 feet, more or less, to the point of commencement.
