A By-law to amend By-law Number 33-79 for the regulation of traffic.

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient and advisable to amend By-law Number 33-79, being a By-law for the regulation of traffic.

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. That Schedule VIII to By-law Number 33-79 be amended by the deletion therefrom of the following under the appropriate columns thereof.




