A By-law to amend the Schedules of Traffic By-law 93-93, relating to PERMIT ONLY OPERATION (TYPES OF LOTS) (Schedule XXVIII), NO PARKING (Schedule XIV) and RATE OF SPEED (Schedule X)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule XXVIII:
