# BY-LAW

Number 188-2002

To amend By-law 93-93,

## THROUGH HIGHWAYS, STOP SIGNS, NO PARKING, NO STOPPING, RATE OF SPEED, FIRE ROUTES

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule III thereto the following items:

### THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Fidelity Avenue	The north limit of Patience Drive and the south limit of the roadway
Maldives Crescent	The south limit of Balmy Way and the north limit of Yukon Lane
Sweetwood Circle	The east limit of Sentimental Way (southerly intersection) to the east limit of Sentimental Way (northerly intersection)
Virtues Avenue	The north limit of Honeymoon Drive and the south limit of the roadway

(2) by adding to Schedule IV thereto the following items:

### STOP SIGNS

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
Balmy Way and Verona Drive	Northbound on Balmy Way
Honeymoon Drive and Patience Drive	Southbound on Patience Drive

- (3) by deleting from Schedule XIV thereto the following item:

**NO PARKING**

Sunforest Drive	Both	a point 10 metres north of Bovaird Drive and a point 50 metres north thereof	8:00a.m. – 5:00p.m. Monday to Friday

Burnt Elm Drive	West	a point 29 metres north of Milkweed Crescent and a point 113 metres north thereof	8:00a.m. – 5:00p.m. Monday to Friday
Treeline Boulevard	East	a point 20 metres north of Merlin Drive and a point 100 metres north thereof	8:00a.m. – 5:00p.m. Monday to Friday

Treeline Boulevard	40	a point 40 metres south of Golan Drive and a point 40 metres north of Linstock Drive	Anytime




