1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to the specified columns of Schedule X thereto the following items:

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Hanover Road	40	Homeland Court/Huntington Court and a point 108 metres west of Huntingwood Crescent	Anytime
Hilldale Crescent	40	A point 44 metres west of Hallcrown Court and Central Park Drive (easterly intersection)	Anytime

2. This by-law shall not come into force until approved by the council of the Regional Municipality of Peel.
