BY-LAW

Number 201-82

To amend By-law 200-82
as amended.
(Part of Lot 4, Concession 2,
East of Hurontario Street)

The Council of The Corporation of the City of Brampton ENACTS
as follows:

1. By-law 200-82 , as amended, is hereby further
amended:

- (1) by changing the zoning designation of the lands
shown outlined on Schedule A to this by-law from
INDUSTRIAL TWO (M2) to INDUSTRIAL TWO - SECTION
188 (M2 - SECTION 188);
- (2) By deleting Sheet 35 of Schedule A thereof, and
substituting therefor Schedule B to this by-law;
- (3) by adding thereto the following section:

"188 The lands designated M2 - SECTION 188 on
Schedule A hereto attached:

188.1 shall be used only for the following
purposes:

- 1) sale, service and repair of
snowmobiles, boats and accessories,
- 2) offices other than ones for medical,
dental, drugless practitioners or
real estate purposes,
- 3) those purposes permitted by section
32.1.


188.2 shall be subject to the following
requirements and restrictions:


- 1) the total gross floor area used
for offices shall not exceed
289 square metres.

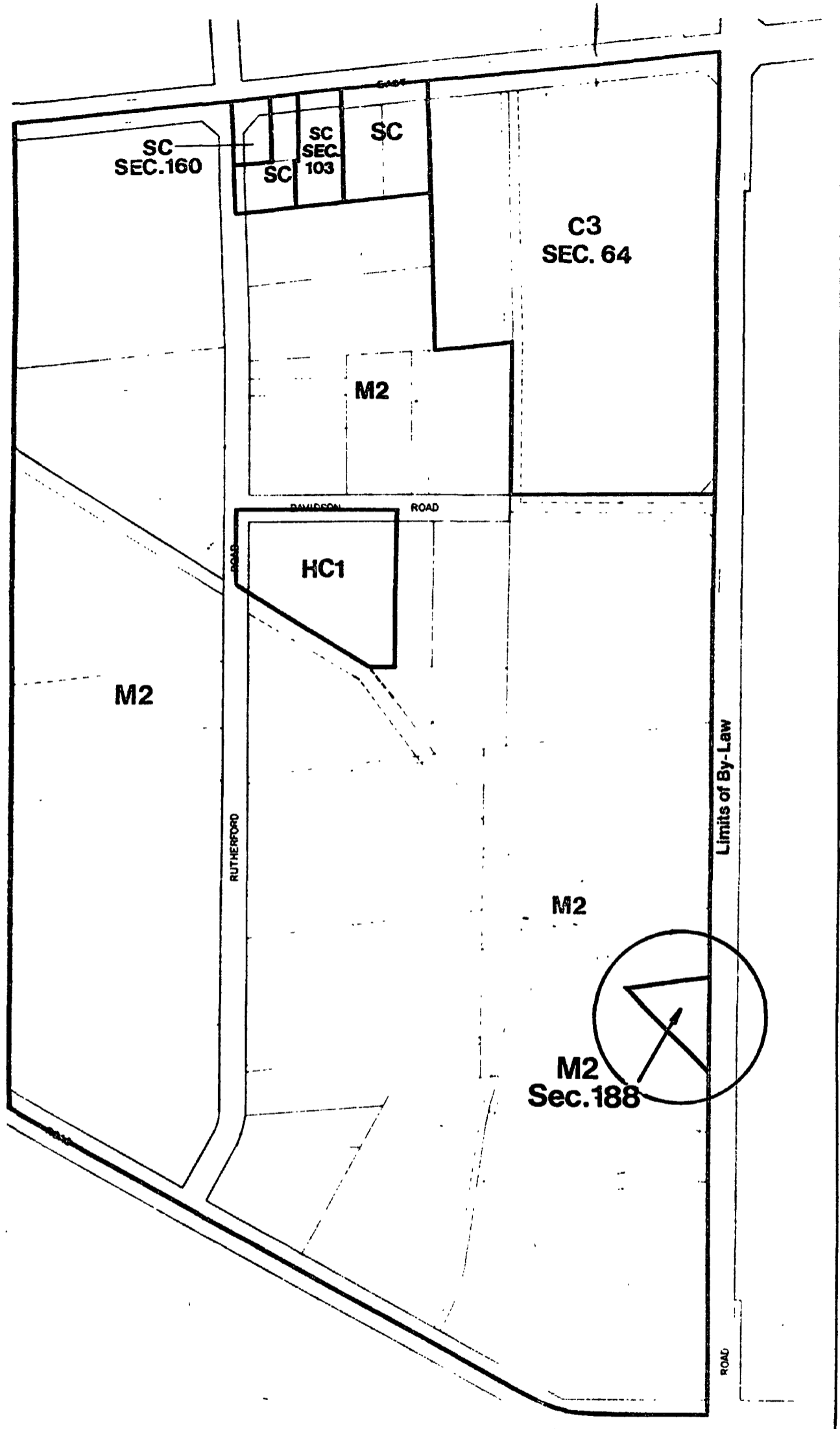
188.3 shall also be subject to the requirements and restrictions of the M2 Zone which are not in conflict with the ones set out in SECTION 188.2."

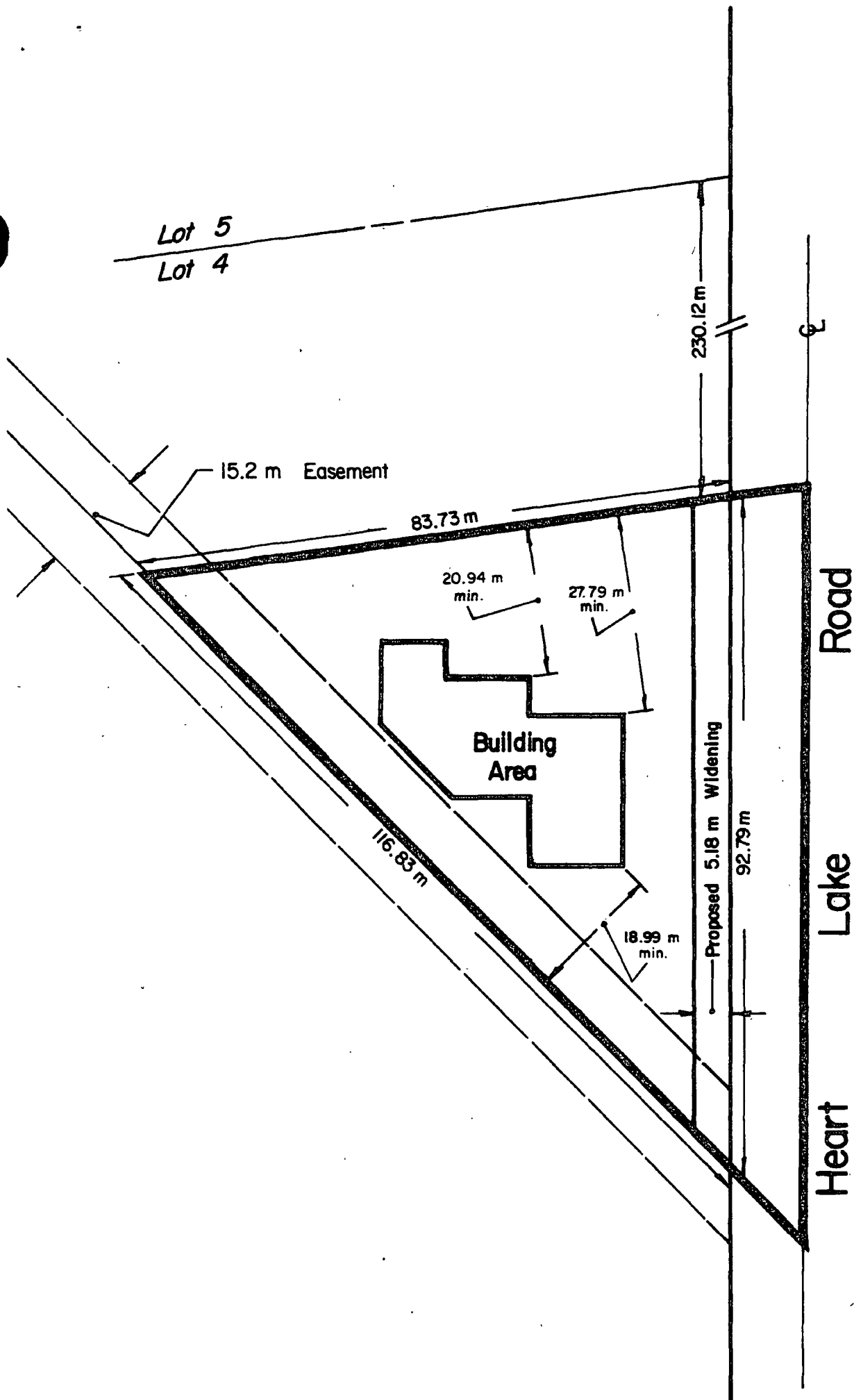

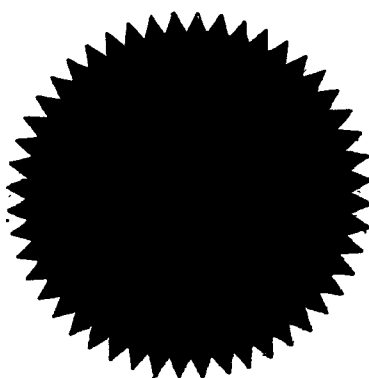
