



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 203-85

To amend By-law 160-84
(Rowntree Drain)

WHEREAS the council of The Corporation of the City of Brampton finally passed By-law 160-84 on 13 August 1984, authorizing the construction of certain drainage works on Lots 11, 12, 13, Concession 4, West of Hurontario Street, geographic Township of Chinguacousy, to be known as the Rowntree Drain;

AND WHEREAS Harold and Isabelle McClure, the owners of part of the west half of Lot 11, Concession 4, West of Hurontario Street, geographic Township of Chinguacousy, have requested an extension to the Rowntree Drain;

AND WHEREAS section 78 of the Drainage Act (R.S.O. 1980, c. 126, as amended) authorizes the council to undertake and complete such an extension to drainage works, on the report of an engineer appointed to it;

AND WHEREAS Jack K. Young was appointed as the engineer for the Rowntree Drain;

AND WHEREAS, on 15 July 1985, Jack K. Young filed a report, dated 5 July 1985, on the requested extension to the Rowntree Drain;

AND WHEREAS the council is of the opinion that this extension of the drainage area is desirable;

NOW THEREFORE the council of The Corporation of the City of Brampton, pursuant to the Drainage Act, ENACTS AS FOLLOWS:

1. Sections 1 and 2 of By-law 160-84 are repealed, and the following substituted therefor:

- "1. (1) The report prepared by Jack K. Young and dated 12 April 1984 is hereby adopted, and the drainage works as therein described, to be known as the Rowntree Drain is hereby authorized, and shall be completed in accordance therewith.
- (2) To pay for the cost of constructing the drainage works, a special rate shall be levied upon lands and roads, as set forth in Schedule A to this by-law, to be collected in the same manner and at the same time as other taxes are collected.


2. (1) The report prepared by Jack K. Young and dated 5 July 1985 is hereby adopted, and the extension of the drainage works (known as the Rowntree Drain) as therein described is hereby authorized, and shall be completed in accordance therewith.
- (2) To pay for the cost of constructing this extension to the drainage works, a special rate shall be levied upon lands and roads, as set forth in Schedule B to this by-law, to be collected in the same manner and at the same time as other taxes are collected."
2. Schedule A to this by-law is hereby added to By-law 160-84, as Schedule B thereto, and forms part of By-law 160-84.


