

Dear Mr. Reid:

This letter will confirm our interest in the above mentioned project. After meeting with Mr. R. D. Savage and yourself last week to discuss the project requirements, it is our understanding that the scope of work is as follows:

- 1) Develop a preliminary master plan showing two lit tennis courts complete as per the Town's specifications and one field house, incorporating a men's and woman's washroom plus a storage garage.
- 2) Prepare working drawings, specifications and tender documents for the above.
- 3) Contract administration and supervision for the above.

We would propose an upset figure of \$7,000.00 for the required work. Time spent would be invoiced monthly on the following basis:

Assuming the above is acceptable with you, we would suggest that this letter form the basis of the contract. A signed copy returned to our office will allow us to proceed with the work as described.





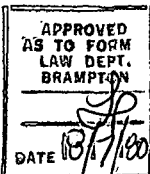
