

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

To amend By-law 200-82 (parking of trailers and large vehicles), and to repeal and replace By-laws 283-80 and 166-83

The Council of The Corporation of the City of Brampton ENACTS as FOLLOWS:

- 1. By-law 200-82, as amended, is hereby further amended:
 - (1) by deleting from section 5.0 (DEFINITIONS) the definition of <u>MOTOR VEHICLE</u>, and substituting therefor the following:

"MOTOR VEHICLE includes an automobile, truck, bus, selfpropelled mobile home, motorcycle, motor-assisted bicycle, snowmobile, farm implement, and any other vehicle propelled or driven otherwise than by muscular power,"

- (2) by deleting from section 5.0 (DEFINITIONS) the word "<u>TRAILER</u>" beginning the definition of <u>TRAILER</u>, and substituting therefor the words "TRAILER, HOUSE";
- (3) by adding to section 5.0 (DEFINITIONS) the following definitions:

<u>CATERING TRUCK</u> shall mean a truck cab and frame with a catering box installed thereon, having a vehicle weight not in excess of 3300 kilograms, from which various beverages, foods and sundries are sold at various locations.

LARGE MOTOR VEHICLE shall mean any motor vehicle having a vehicle weight greater than 2500 kilograms,

<u>VEHICLE WEIGHT</u> shall mean the weight of the vehicle itself, as set out in the manufacturer's specifications."

- (4) by deleting subsection 6.16 and substituting therefor the following:
 - "6.16 (a) Travel trailers, house trailers and mobile homes may not be located in any zone if used or intended to be used in that location for the accommodation of and occupation by persons.

- (b) Travel trailers and house trailers may be stored in any zone in accordance with the other provisions of this by-law."
- (5) by deleting subsection 10.7 and substituting therefor the following:

"10.7 PARKING OF TRAILERS AND LARGE VEHICLES

- (1) A person shall not park or store, or permit to be parked or stored, on any lot in a residential zone, a large motor vehicle other than a catering truck, unless it is at the time being used to make a delivery or to provide a service.
- (2) Except as permitted by clause 3 of this subsection, a person shall not park or store, or permit to be parked or stored, a boat, a snowmobile, or any truck trailer, mobile home, house trailer, travel trailer, or any other type of trailer, in an exterior side yard or in the front yard, including the part of the driveway therein, of any lot in a residential zone.
- (3) A travel trailer not exceeding 5 metres in length when closed may be parked or stored in the part of the driveway that is in the front yard.
- (4) Only <u>one</u> of the following vehicles or vehicle combinations may be parked or stored on any one lot in a residential zone:
 - (a) a boat,
 - (b) a snowmobile,
 - (c) a trailer,
 - (d) a boat on a trailer, together not exceeding 7 metres in length,
 - (e) one or two snowmobiles on a trailer, together not exceeding 7 metres in length.
- (5) A boat or a trailer
 - (a) shall not occupy any parking space required under this by-law, unless otherwise permitted, and,
 - (b) shall not, on a lot of which the rear lot line abuts a street or a reserve owned by a public authority, be parked or stored closer than 7.5 metres to the said rear lot line."

(6) by deleting subsection 10.11.8.

2. By-laws 283-80 and 166-83 are hereby repealed.
