BY-LAW

Number 210-77

A By-law to amend By-law 115-77 being a By-law to amend By-law 5500 as amended to prohibit or regulate the use of land and the erection, use, bulk, height and location of building on part of the east half of Lot 15, ~~Concession 2, in the former Town of Mississauga,~~ now in the City of Brampton.

The Municipal Council of the Corporation of the City of Brampton ENACTS as follows:

1. That the first two paragraphs of Section 1 of By-law 115-77 be deleted and the following substituted therefor:

"By-law Number 5500 as amended, being the City of Mississauga Zoning By-law is hereby amended by adding thereto the following "Section":

760. Notwithstanding the "RM4" and "HRM4" Zone designations the lands delineated on Schedule "B" of this By-law as "RM4 Section 760 and HRM4 Section 760" shall only be used for nursing home and home for the aged and auxiliary uses in compliance with the following regulations:"

2. That the first paragraph of Section 2 of By-law 115-77 be deleted and the following substituted therefor:

"Map Number 47 contained in Schedule "B" attached to By-law Number 5500 as amended, is hereby amended by changing thereon from "A" to "RM4" Section 760 and HRM4 Section 760" the zone designations of a parcel of land being part of Lot 15, Concession 2, W.H.S. in the former Town of Mississauga, now in the City of Brampton."

3. That Schedule "A" to By-law 115-77 be deleted and the attached Schedule "A" substituted therefor.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 22nd day of August 1977.

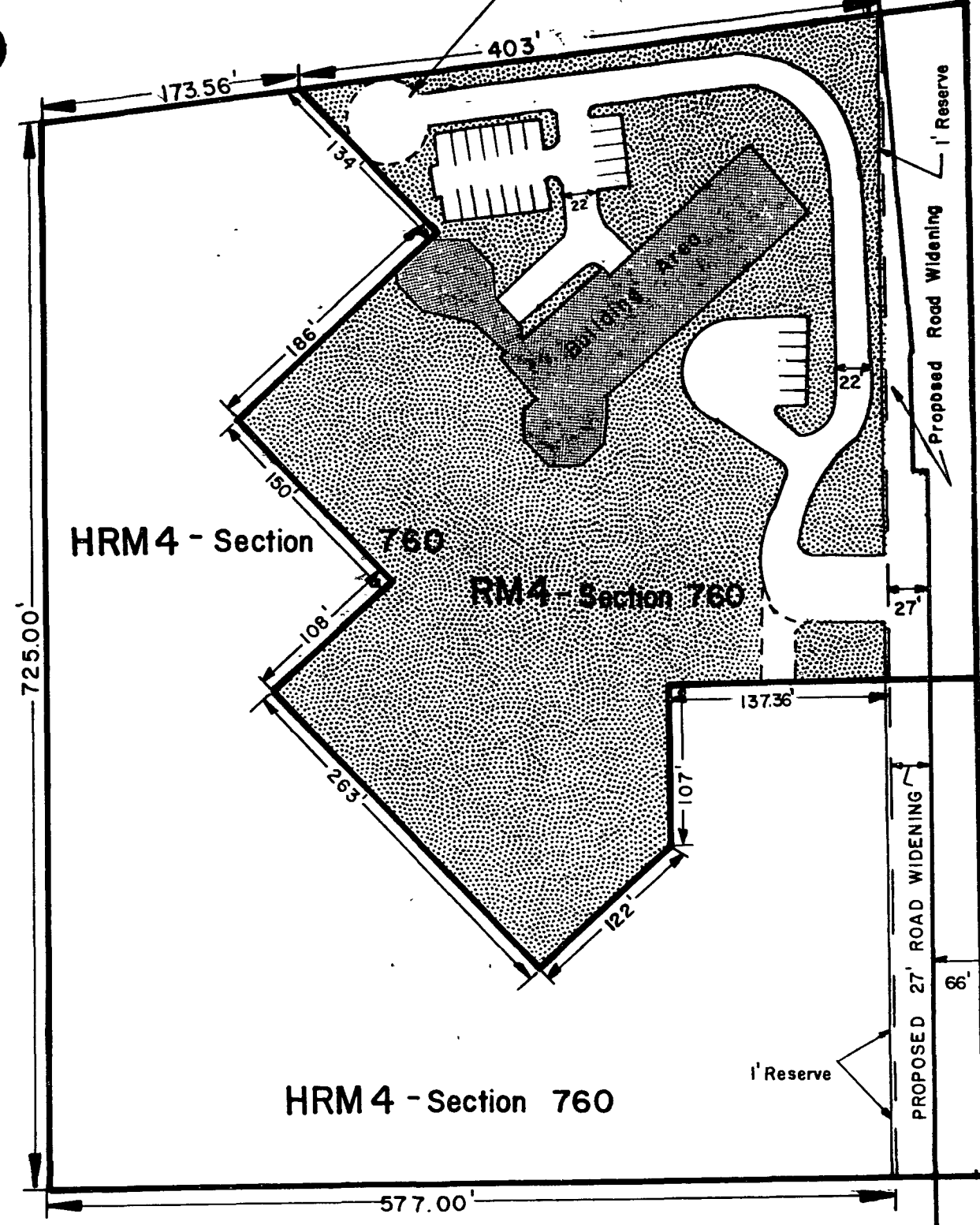

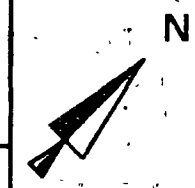

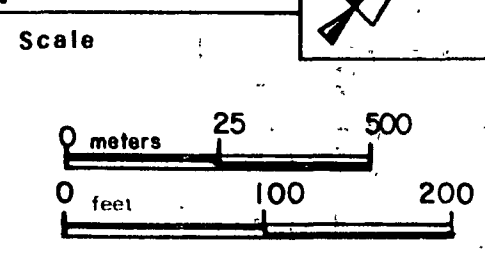
LOT 15 Concession 2 W.H.S. Toronto Township
