Council, at its meeting of February 26, 1979, agreed to the extension of the Heart Lake Transit Agreement to June 30, 1979.



#### THE ATTACHED EXTENSION DATED MARCH 5, 1979 IS AGREEABLE

MEMORANDUM OF AGREEMENT made in duplicate this 16 day of the August 1977.

#### BETWEEN:

CONSOLIDATED BUILDING CORPORATION LIMITED, and HEART LAKE DEVELOPMENTS COMPANY LIMITED, both being companies incorporated under the laws of the Province of Ontario, carrying on business under the firm name and style of HEART LAKE

hereinafter called 'Heart Lake'

OF THE FIRST PART

AND

THE CORPORATION OF THE CITY OF BRAMPTON hereinafter called the 'City'

OF THE SECOND PART

WHEREAS Heart Lake is involved in the development of a new residential area known as the Heart Lake Area;

AND WHEREAS the development of the said Area has progressed to the point where Heart Lake has requested transit service to the said Area;

AND WHEREAS the City is prepared to provide transit service to the Heart Lake Development Area, in accordance with the terms of this agreement.

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT in consideration of the sum of One Dollar (\$1.00) now paid by the parties, one to the other (receipt of which is hereby acknowledged), and of the mutual covenants and agreements hereinafter contained the parties hereto do covenant and agree each with the other as follows:

The City will purchase one (1) used GMC model TDH 4512 transit bus and repair and equip the said bus for transit service. Commencing Monday, August 29, 1977 or so soon thereafter as the said used bus is available for service,

the City shall provide such transit service as the City deems necessary to the Heart Lake Development Area, using City personnel and facilities and the used bus. In addition, other City vehicles may be used if and when they are available and the City deems it appropriate to use them.

Heart Lake agrees to be responsible for all costs involved in providing Transit service to the Heart Lake Development Area from Monday, August 29, 1977 to May 31, 1978 inclusive. It is hereby agreed that such costs shall include the cost of purchase of one (1) used bus as set out in Paragraph 1 above, the full cost of body repair and repainting of the said bus, the full cost of equipping the vehicle with six transit type tires, the full cost of mechanically certifying the vehicle for transit service, and all on-going costs of providing transit service to the Heart Lake Development Area, which on-going costs shall be calculated on the basis of Twenty-One Dollars (\$21.00) per hour per bus for the period commencing August 29, 1977 to December 31, 1977. The on-going costs shall be subject to adjustment by the City at December 31, 1977.

The City shall decide the route or routes to be operated and shall determine the hours of service and frequency of service during the term of this agreement, and shall include Saturday service unless in the discretion of the City such service is not warranted.

The parties hereto agree that the transit service will be operated entirely by the City with City of Brampton transit personnel only.

During the term of this agreement Heart Lake will be credited with all revenue received by the City from the transit service to and from the Heart Lake Development Area. Heart Lake will be provided with a monthly statement of revenue and will be billed on a monthly basis for the cost of operating the

transit service. Heart Lake agrees to pay to the City within thirty (30) days, the cost of operating the transit service as billed by the City less the amount of any revenue received but not previously credited, as shown on the last revenue statement.

The parties hereto agree that the used bus to be purchased by the City in accordance with the terms of this agreement, shall be the property of the City and upon termination of this agreement the City shall have the absolute right to use or dispose of the said bus as the City shall determine.

This agreement shall run for a period commencing Monday, August 29, 1977 and terminating May 31, 1978, provided that the City shall have the right to terminate this agreement at any time prior to May 31, 1978 on one (1) month's written notice, mailed to Consolidated Building Corporation Limited and Heart Lake Developments Company Limited, 99 Avenue Road, Toronto, Ontario, M5R 2G6, by prepaid regular post which notice shall be deemed to be received two (2) days after the date of mailing. Heart Lake shall have the right to terminate this agreement at any time if the total costs incurred or to be incurred by Heart Lake hereunder should exceed Fifty-five Thousand (\$55,000.00) Dollars, on one (1) month's written notice, mailed to the Corporation of the City of Brampton, 24 Queen Street East, Brampton, Ontario, L6V 1A4, attention Mr. K. R. Richardson, Clerk, by prepaid regular post which notice shall be deemed to be received two (2) days after the date of mailing. Heart Lake shall not be responsible for any costs incurred by the City in operating transit service to the Heart Lake Development Area after May 31, 1978 or if this agreement is sooner terminated after the termination date as specified in the notice given pursuant to this paragraph.
