

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number _____216-91

To authorize an application to The Regional Municipality of Peel for the issuance of debentures in the amount of \$23,832,000 on behalf of the Corporation of the City of Brampton

WHEREAS section 123 of the <u>Municipal Act</u> authorizes a municipal council to borrow money for the purposes of the municipal corporation;

AND WHEREAS the Corporation of The City of Brampton has obtained the approval of the Ontario Municipal Board under section 64 of the <u>Ontario Municipal Board Act</u> for the projects described in Schedule A to this by-law;

AND WHEREAS section 94 of the <u>Regional Municipality of</u> <u>Peel Act</u> permits the Regional Municipality of Peel to borrow money for the purposes of any area municipality and to issue debentures therefor;

AND WHEREAS section 1(a) of the <u>Regional Municipality of</u> <u>Peel Act</u> defines "area municipality" so as to include the Corporation of The City of Brampton;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The City Clerk is hereby instructed to request, on behalf of the Corporation of the City of Brampton, the Council of the Regional Municipality of Peel to pass a by-law authorizing the issue and sale of debentures in the amount of \$23,832,000 for the purposes of financing the projects described in Schedule A to this by-law, in accordance with the orders of the Ontario Municipal Board listed in Schedule A to this by-law.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 16th day of 0ct., 1991.
