To provide for the Building and By-law Enforcement Committee to hold hearings in respect of the proposed sign by-law and any future amendments thereto

WHEREAS paragraph 141 of section 210 of the <u>Municipal Act</u> authorizes the councils of local municipalities to pass by-laws for prohibiting or regulating signs and other advertising devices;

AND WHEREAS paragraph 144a of section 210 of the <u>Municipal</u> <u>Act</u> requires a council to give notice of the proposed by-law under paragraph 141 and notice of the council meeting at which the proposed by-law is to be discussed and to afford any person who applies, the opportunity to be heard in respect of the proposed by-law;

AND WHEREAS section 106 of the <u>Municipal Act</u> provides that where a council is required by law to hear interested parties or afford them an opportunity to be heard, the council may provide by by-law for a committee of the council to hear such parties;

AND WHEREAS it is the intention of the Council of The Corporation of the City of Brampton to pass a by-law pursuant to paragraph 141 of section 210 of the <u>Municipal Act</u>; NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The Building and By-law Enforcement Committee of Council shall, in the place and stead of Council, afford an opportunity to be heard and hear all persons who apply to be heard in respect of any proposed by-law, including an amending by-law, to be discussed by Council where the proposed by-law is to be enacted pursuant to paragraph 141 of section 210 of the Municipal Act.

2. The City Clerk shall cause the notice required under paragraph 144a of section 210 of the <u>Municipal Act</u> to be published. Such notice shall state the date of the Council meeting at which the proposed by-law is to be considered, and shall provide that persons applying to be heard in respect of the proposed by-law shall be heard at the regular meeting of the Building and By-law Enforcement Committee next preceding the date of the Council meeting referred to in the notice.

3. The City Clerk or a person designated by him shall prepare, on behalf of the Building and By-law Enforcement Committee, the report to Council in respect of the hearing as required by section 106 of the Municipal Act.
