A By-law to provide for composite ballots.


WHEREAS it is deemed expedient to provide for composite ballots at the Municipal Election pursuant to the provisions of The Municipal Elections Act,


NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. At the next municipal election to be held on the 6th day of December, 1976 there shall be used composite ballots containing:
  - a) The names of candidates for the offices of the Mayor, Regional Councillor, Alderman and School Trustee for the Peel Board of Education.
  - b) The names of candidates for the offices of the Mayor, Regional Councillor, Alderman, School Trustee for the Dufferin-Peel Roman Catholic Separate School Board and Separate School Trustee on the Peel Board of Education for secondary school purposes.
2. The ballot papers shall be in the form attached to and forming part of this By-law and shall

contain the names of the candidates for each office arranged alphabetically in order of their names, or, if there are two or more candidates for the same office with the same surname, in order of their given names.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 25th day of October, 1976.
