To amend By-law 33-79 being a
by-law for the regulation of
Traffic

WHEREAS the Council of The Corporation of the City of Brampton deems it expedient and advisable to amend By-law 33-79, being a by-law for the regulation of traffic:

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 33-79, as amended, is hereby further amended by the DELETION from Schedule I thereof the following items under the appropriate columns thereof:

NO PARKING ON SPECIFIED HIGHWAYS

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>SIDE</u>	<u>COLUMN 3</u> <u>BETWEEN</u>	<u>COLUMN 4</u> <u>TIMES OR DAYS</u>
Brenda Avenue	West	Harold Street & Kingsview Blvd.	Anytime

2. By-law 33-79, as amended, is hereby further amended by the ADDITION to Schedule XII thereof the following items under the appropriate columns thereof:

SCHOOL BUS LOADING ZONES

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>SIDE</u>	<u>COLUMN 3</u> <u>BETWEEN</u>	<u>COLUMN 4</u> <u>SCHOOL OR INSTITUTION</u>
Brenda Avenue	West	A point 131 metres north of Kingsview Blvd. and a point 10 metres north of Kingsview Blvd.	Ridgeview School

3. By-law 33-79, as amended, is hereby further amended by the ADDITION to Schedule I thereof the following items under the appropriate columns thereof:


NO PARKING ON SPECIFIED HIGHWAYS

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>SIDE</u>	<u>COLUMN 3</u> <u>BETWEEN</u>	<u>COLUMN 4</u> <u>TIMES OR DAYS</u>
Brenda Avenue	West	Harold Street & a point 131 metres north of Kingsview Blvd.	Anytime
Brenda Avenue	West	A point 10 metres north of Kingsview Blvd & Kingsview Blvd.	Anytime
