# BY-LAW

**Number** 226-2000

A By-law to Appoint a Chief Building Official and Inspectors for the Enforcement of the Building Code Act and Regulations and to Repeal By-law 97-2000

WHEREAS section 3(2); of the *Building Code Act*, S.O. 1992 requires the Council of each municipality to appoint a Chief Building Official and such inspectors as are necessary for the purposes of the enforcement of the *Building Code Act*;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. Brenda Campbell is hereby appointed as the Chief Building Official for the City of Brampton;
2. Ronald Charles Horsley or Lillyan McGinn are hereby appointed as Deputy Chief Building Officials for the City of Brampton, and shall exercise all the powers and authority of the Chief Building Official during her absence; and




