# **BY-LAW**

Number \_\_\_\_\_ 232-91

To stop up and close and authorize the sale of part of Tilden Wood Drive on Registered Plan 43M-524

WHEREAS it is deemed expedient in the interest of The Corporation of the City of Brampton that the part of Tilden Wood Drive on Registered Plan 43M-524 designated as Part 1 on Plan 43R-18778 be stopped up and closed and sold to the owner of the abutting land;

AND WHEREAS notice of the intention to pass this bylaw has been published once a week for four consecutive weeks in the Brampton Guardian, a newspaper published in the City of Brampton;

AND WHEREAS the said Corporation has given notice to The Regional Municipality of Peel, pursuant to Section 49 of the <u>Regional Municipality of Peel Act</u> (R.S.O. 1980, c. 440, as amended) and The Regional Municipality of Peel has indicated that it does not object to such stopping up;

AND WHEREAS the Council for the said Corporation has heard in person or by counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The part of Tilden Wood Drive on Registered Plan 43M-524 designated as Part 1 on Plan 43R-18778 is hereby stopped up and closed.

2. The sale of the part of Tilden Wood Drive on Plan 43M-524 designated as Part 1 on Plan 43R-18778 to Fayette Developments Inc. and Rosapac Developments Inc. carrying on business as Darcel Developers, is hereby authorized. The consideration for the sale shall be the conveyance to The Corporation of the City of Brampton of the part of Block 135, Registered Plan 43M-524 designated as Parts 1 and 2 on Plan 43R-18779.  The Mayor and Clerk are hereby authorized to execute all documents and instruments approved by the City Solicitor as may be necessary to effect the conveyance of the said lands.
The affidavit of Leonard J. Mikulich attached as Schedule A to this by-law forms part of this bylaw.
