# Number 232-2009

To amend Interim Control By-Law 127-2009, an Interim Control By-Law applicable to part of the area subject to Zoning By-Law 270-2004, as amended.

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 127-2009 is hereby amended as follows:

1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1," the following:

"and Section 1.2"

- 1.2 The following is added as Section 1.2:
- "1.2 The lands described as Part of the west half of Lot 3, Concession 1 E.H.S. (160 Main Street South) and referenced as the lands subject to Specific Exemption From Interim Control By-Law 127-2009, as amended by By-Law 232-24as outlined on Schedule A to this By-Law shall permit a 960 sq.m. (10,334 sq.ft.) addition to the existing supermarket."


