To amend By-law 200-82, as amended (part of Lot 2, Concession 2, E.H.S., geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS as follows:


1. By-law 200-82, as amended, is hereby further amended:

- (1) by changing the zoning designation of the land shown outlined on Schedule A to this by-law from SERVICE COMMERCIAL (SC) to INDUSTRIAL ONE (M1), such lands being part of Lot Two, Concession Two, East of Hurontario Street, of the geographic Township of Chinguacousy,
- (2) by deleting Sheet 34 of Schedule A thereto, and substituting therefor Schedule B to this by-law,

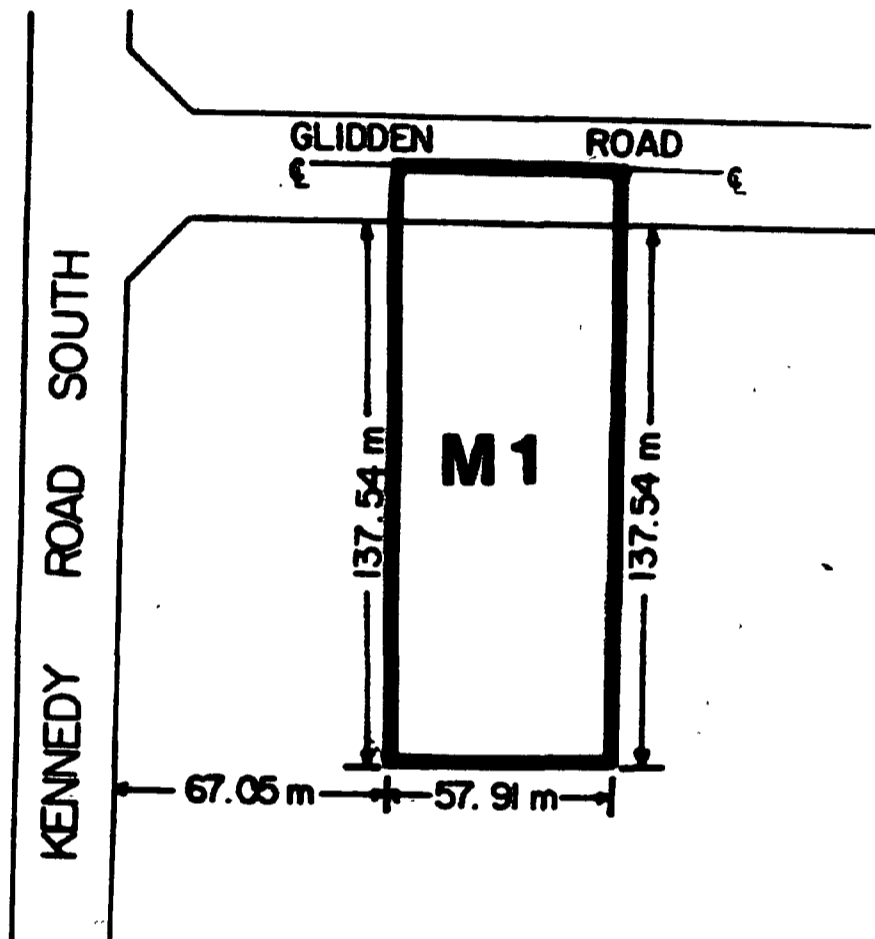
READ a FIRST, SECOND and THIRD TIME, and Passed In Open Council,

PART LOT 2, CON. 2 E.H.S.

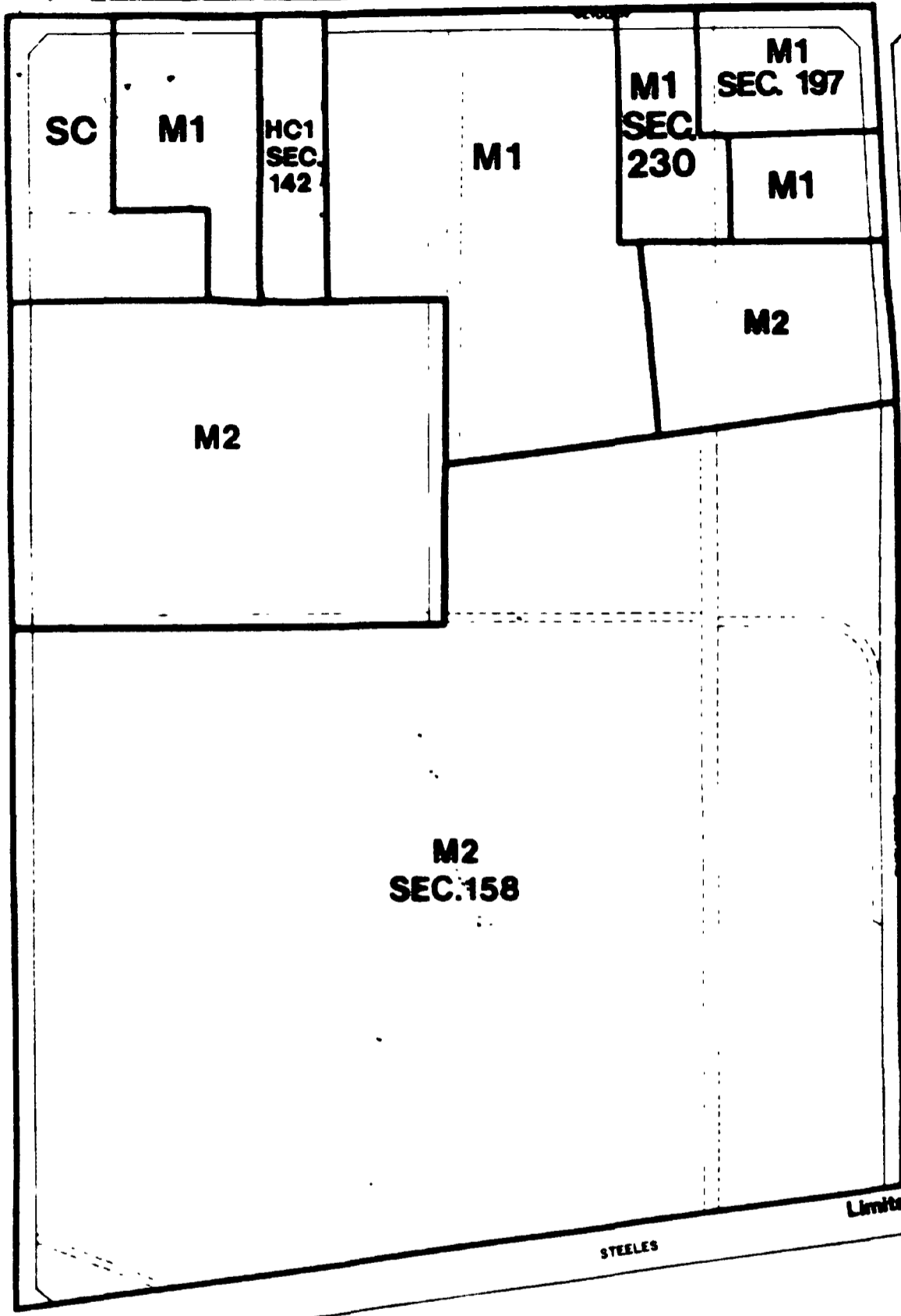


