To amend By-law 861, as amended,
(Part of Lot 10, Concession 1, E.H.S.,
geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton
ENACTS as follows:

1. Schedule A of By-law 861, as amended, is hereby further amended by changing the zoning designations of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-HOLDING (R5-SECTION 364(H)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-HOLDING-SOLAR (R5-SECTION 364(H)(S1)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-HOLDING-SOLAR (R5-SECTION 364(H)(S2)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-HOLDING-SOLAR (R5-SECTION 364(H)(S3)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 411-HOLDING-SOLAR (R5-SECTION 411(H)(S1)), RESIDENTIAL MULTIPLE RMA - SECTION 365-HOLDING (RMA-SECTION 365(H)), RESIDENTIAL MULTIPLE RMA - SECTION 365-HOLDING-SOLAR (RMA-SECTION 365(H)(S1)), RESIDENTIAL MULTIPLE RMA - SECTION 365-HOLDING-SOLAR (RMA-SECTION 365(H)(S2)) and RESIDENTIAL MULTIPLE RMA - SECTION 365-HOLDING-SOLAR (RMA-SECTION 365(H)(S3)) to RESIDENTIAL SINGLE FAMILY 5 - SECTION 364 (R5-SECTION 364), RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-SOLAR (R5-SECTION 364(S1)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-SOLAR (R5-SECTION 364(S2)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 364-SOLAR (R5-SECTION 364(S3)), RESIDENTIAL SINGLE FAMILY 5 - SECTION 411--SOLAR (R5-SECTION 411(S1)), RESIDENTIAL MULTIPLE RMA - SECTION 365 (RMA-SECTION 365), RESIDENTIAL MULTIPLE RMA - SECTION 365-SOLAR (RMA-SECTION 365(S1)), RESIDENTIAL MULTIPLE RMA - SECTION 365-SOLAR (RMA-SECTION 365(S2)) and RESIDENTIAL MULTIPLE RMA - SECTION 365--SOLAR (RMA-SECTION 365(S3)), such lands being part of Lot 10, Concession 1, East of Hurontario Street, in the geographic Township of Chinguacousy.

2. Schedule A to this by-law is hereby attached to By-law 861 as part of Schedule A and forms part of By-law 861.

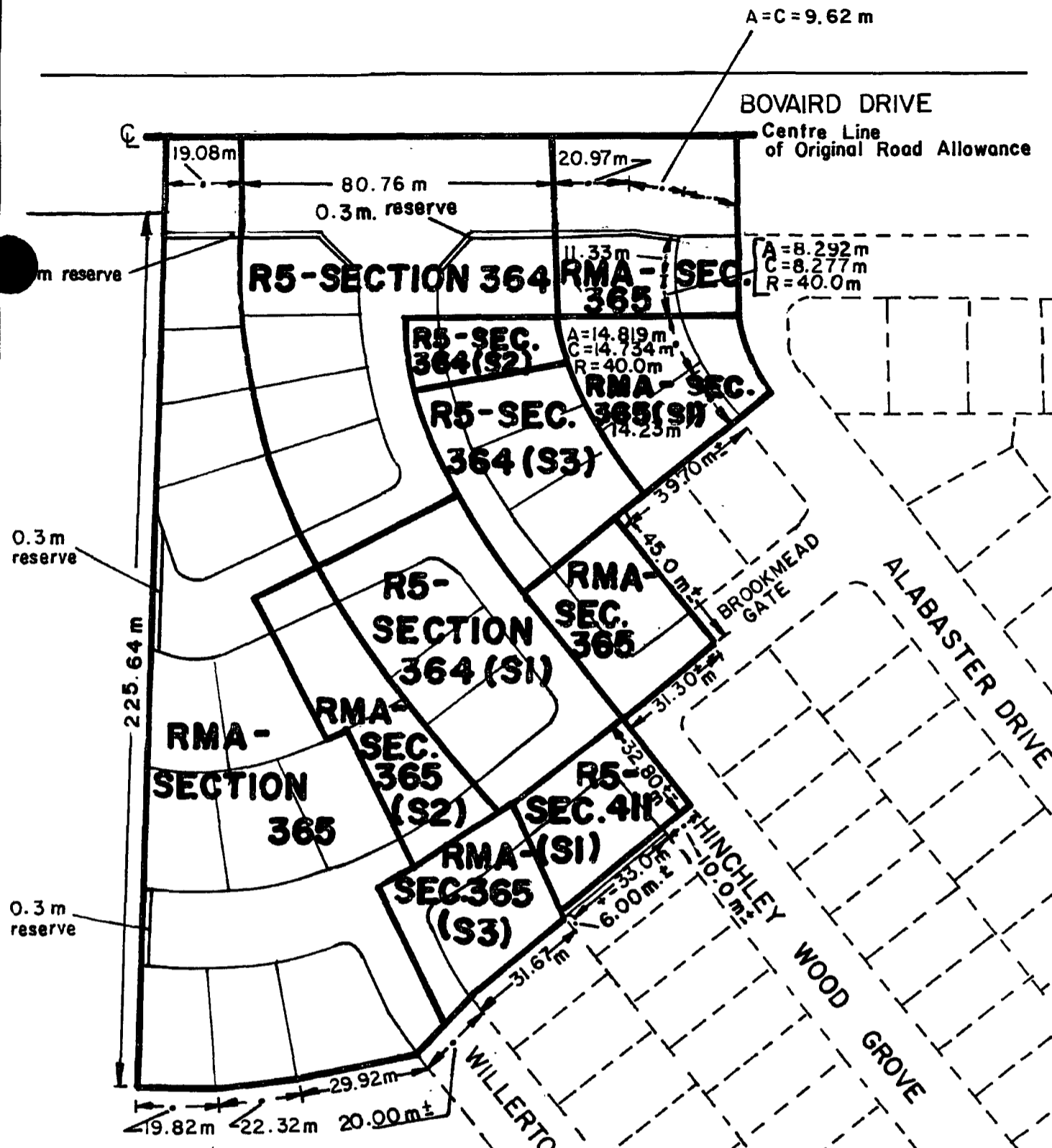
