To change the name of Tilden
Wood Drive (Plan 43M-524)

WHEREAS the Council of The Corporation of the City of Brampton deems it expedient to change the name of part of Tilden Wood Drive;


AND WHEREAS notice of the intention to pass this by-law has been published once a week for four consecutive weeks in the Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;


NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The name of the street shown as "Tilden Wood Drive" on Registered Plan 43M-524, which is described in Schedule A attached hereto, is changed to "Valonia Drive".
2. The affidavit of Leonard J. Mikulich attached as Schedule A hereto shall form part of this by-law.


I, LEONARD J. MIKULICH, City Clerk and Director of Administration for The Corporation of the City of Brampton, MAKE OATH AND SAY:


- (i) Wednesday, October 2, 1991

1. "Tilden Wood Drive" on Registered Plans 43M-524 save and except the part of Tilden Wood Drive designated as Part 1 on Plan 43R-18778 to be changed to and be known as "Valonia Drive".
