To establish certain lands as part of the public highway system (James Potter Road, Bonnie Braes Drive, Beechmont Drive, Libby Road, Angelgate Road, Lloyd Sanderson Drive and Berkwood Hollow Court)

The Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:** 

- The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 5, Concession 3, WHS, designated as Parts 2 and 21 on Plan 43R-34485 are hereby established as part of the public highway system to be part of James Potter Road.
- 2. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 4, Concession 3, WHS, designated as Parts 37 and 42 on Plan 43R-34485 are hereby established as part of the public highway system to be part of James Potter Road.
- 3. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 3, Concession 3, WHS, designated as Parts 72, 95, 101 and 107 on Plan 43R-34485 are hereby established as part of the public highway system to be part of James Potter Road.
- 4. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 4, Concession 3, WHS, designated as Parts 24, 34, 39, 51, 64, 150, 154 and 155 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Bonnie Braes Drive.
- 5. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 5, Concession 3, WHS, designated as Parts 5 and 8 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Beechmont Drive.
- 6. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 5, Concession 3, WHS, designated as Part 14 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Libby Road.

- 7. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 5, Concession 3, WHS, designated as Part 17 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Angelgate Road;
- 8. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 4, Concession 3, WHS, designated as Parts 56, 67, and 70 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Lloyd Sanderson Drive; and,
- 9. The lands acquired by The Corporation of the City of Brampton being described as Part of Lot 3, Concession 3, WHS, designated as Part 123 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Berkwood Hollow Court.
