The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 139-84, as amended, is hereby further amended:
 - (1) by changing on Sheet 8 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by law from AGRICULTURAL (A) to INDUSTRIAL ONE-SECTION 678 (M1-SECTION 678); INDUSTRIAL ONE-SECTION 679 (M1-SECTION 679); INDUSTRIAL TWO (M2); INSTITUTIONAL ONE (II), and FLOOD PLAIN (F).
 - (2) by adding thereto, the following sections:
 - "678 The lands designated M1-SECTION 678 on Sheet 8 of Schedule A to this by-law
 - 678.1 shall only be used for the purposes permitted by section 31.1.1 of this by-law
 - 678.2 shall be subject to the following requirements and restrictions:
 - (1) Maximum Building Height 3 storeys
 - 678.3 shall also be subject to the requirements and restrictions relating to the M1 zone and all general provisions of this by-law which are not in conflict with the ones set out in section 678.2.

- The land designated M1-SECTION 679 on Sheet 8 of Schedule A to this by-law
- 679.1 shall only be used for the purposes permitted by section 31.1.1 of this by-law
- 679.2 shall be subject to the following requirements and restrictions:
 - (1) Landscaped open space area shall be provided and maintained abutting Highway Number 407 and abutting a Flood Plain zone with a width as follows:
 - a) abutting Highway Number 407 12 metres
 - b) abutting a Flood Plan zone 3 metres

679.3 shall also be subject to the requirements and restriction relating to the Ml zone and all general provisions of this by-law which are not in conflict with the ones set out in section 679.2."


