1. By-law 193-83, as amended, is hereby further amended:

(1) by deleting from the specified columns of Schedule VI thereto the following items:

ONE WAY TRAFFIC

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>BETWEEN</u>	<u>COLUMN 3</u> <u>BETWEEN</u>
McMurchy Lane	Nelson Street West and a point 120 metres southerly	Southbound

(2) by adding to the specified columns of Schedule VI thereto the following items:
