To amend By-law 93-93 to regulate use of highways and parking in the City of Brampton

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from the specified columns of Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Knightsbridge Road	The east limit of Central Park Drive and the west limit of Bramalea Road
Rutherford Road North	The east limit of Weybridge Trail (westerly intersection) and the south limit of Herkley Drive
Rutherford Road North	The south limit of Reigate Avenue and the north limit of Queen Street East

(2) by deleting from the specified columns of Schedule IV thereto the following items:




