BY-LAW NUMBER 242-75

A By-law to authorize a capital expenditure in the amount of \$165,000.00 for Fire Training Facilities at Station No. 9.


WHEREAS the Council of the Corporation of the City of Brampton desires to undertake the construction of Fire Training Facilities at Station No. 9 in the City of Brampton.

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. That the Council of the Corporation of the City of Brampton shall undertake the construction of Fire Training Facilities at Station No. 9 as set out in Schedule "A" attached hereto as a capital expenditure at a total estimated cost of \$165,000.00.
2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$165,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ A FIRST, SECOND and THIRD TIME and PASSED in Open Council this 24th day of November, 1975.

Fire Training Facilities at Station No. 9 -

(1945 Williams Parkway) comprising of the following:-

One 6 storey training tower

One pump pumper testing cistern

Three oil fire pits

Asphalt complete training area

Install two hydrants

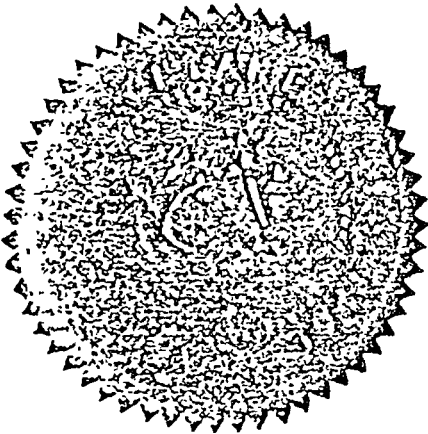

- (1) One 6 storey training tower
- (2) One pump pumper testing cistern
- (3) Three oil fire pits
- (4) Asphalt complete training area
- (5) Install two hydrants

and may pass all requisite by-laws, and The Regional

Municipality of Peel may issue debentures therefor not exceeding \$45,000.00 and not to exceed the net cost of such undertaking to the applicant, for a term not to exceed twenty years.
