**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to THROUGH HIGHWAYS (Schedule III) and
STOP SIGNS (Schedule IV)**

The Council of the Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Pannahill Drive	The east limit of Degrey Drive (westerly intersection) and the west limit of The Gore Road
Skyvalley Drive	The north limit of the roadway and the north limit of Cottrelle Boulevard
Crystalhill Drive	The north limit of Castlemore Road and the east limit of Humberwest Parkway
Bellchase Trail	The south limit of Castle Oaks Crossing and the west limit of Highway 50

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Pannahill Drive	The east limit of Degrey Drive (westerly intersection) and the west limit of Strathdale Road / Oakhaven Road
Pannahill Drive	The east limit of Strathdale Road / Oakhaven Road and the west limit of The Gore Road
Skyvalley Drive	The south limit of Pannahill Drive and the north limit of Lynngrove Way
Skyvalley Drive	The south limit of Lynngrove Way and the north limit of Cottrelle Boulevard
Crystalhill Drive	The west limit of the roadway and the north limit of Garthson Gate
Crystalhill Drive	The south limit of Garthson Gate and the north limit of Castlemore Road
Bellchase Trail	The south limit of Castle Oaks Crossing and the north limit of Franktown Drive

- Bellchase Trail The south limit of Franktown Drive and the west limit of Amy Avenue/Ironshield Drive
- Bellchase Trail The east limit of Amy Avenue / Ironshield Drive and the west limit of Clarkway Drive

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:
