To amend By-law 200-82, as amended.
(part of Lot 1, Concession 1,
W.H.S. (Chinguacousy))

The Council of The Corporation of the City of Brampton ENACTS as follows:


1. By-law 200-82, as amended, is hereby further amended:

- (1) by changing the zoning classification of the land shown outlined on Schedule A to this by-law from RESIDENTIAL HOLDING (RH) to RESIDENTIAL SINGLE-FAMILY C (R1C), such lands being part of Lot 1, Concession 1, W.H.S., of the geographic Township of Chinguacousy,
- (2) by changing the zoning classification of the land shown outlined on Schedule B to this by-law from RESIDENTIAL SINGLE FAMILY B - SECTION 227 (R1B - SEC. 227) to RESIDENTIAL SINGLE FAMILY C - SECTION 227 (R1C - SEC. 227), and
- (3) by deleting Sheet 22 of Schedule A thereto, and substituting therefor Schedule C to this by-law.

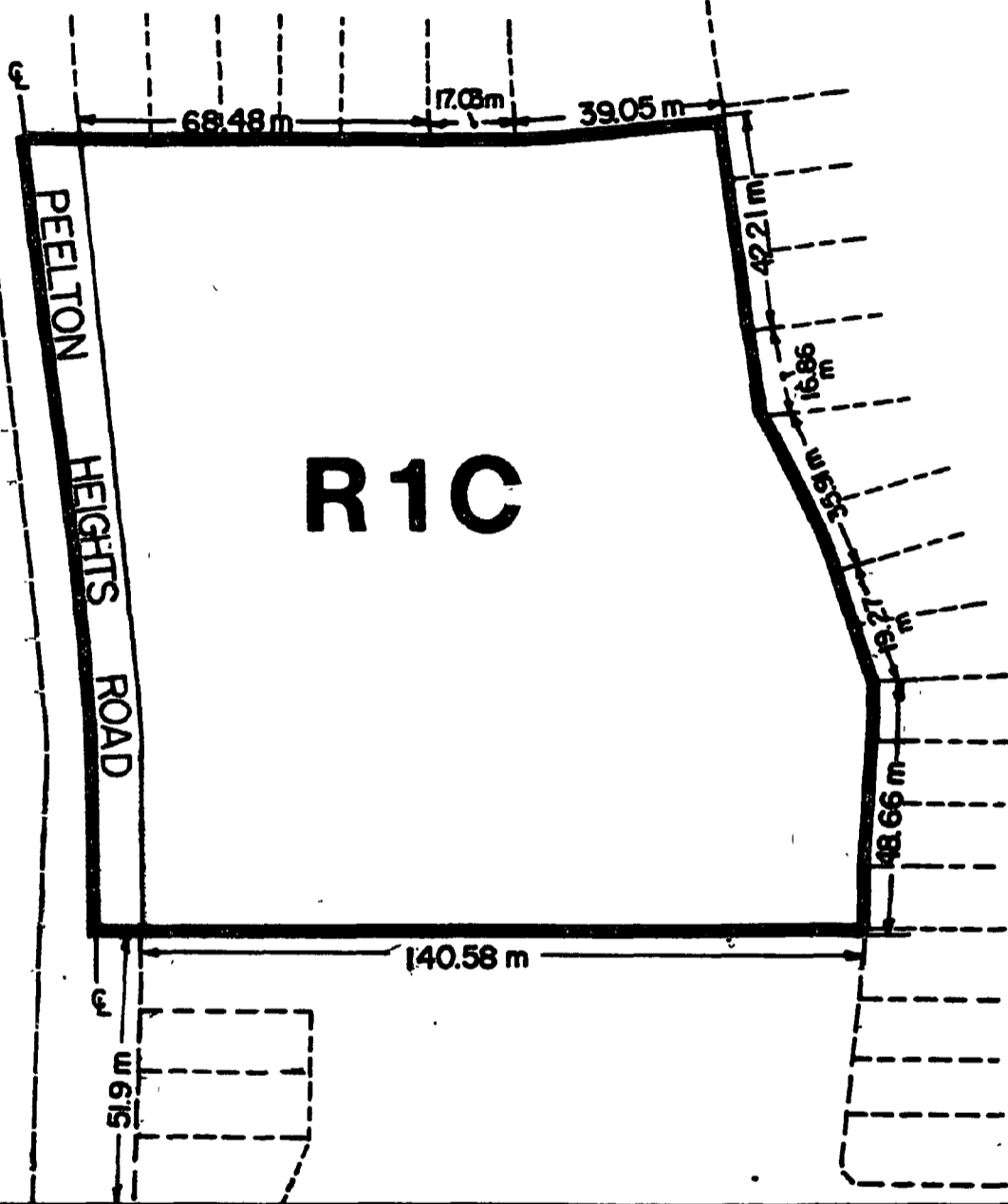

PART LOT 1, CONCESSION 1 W.H.S.

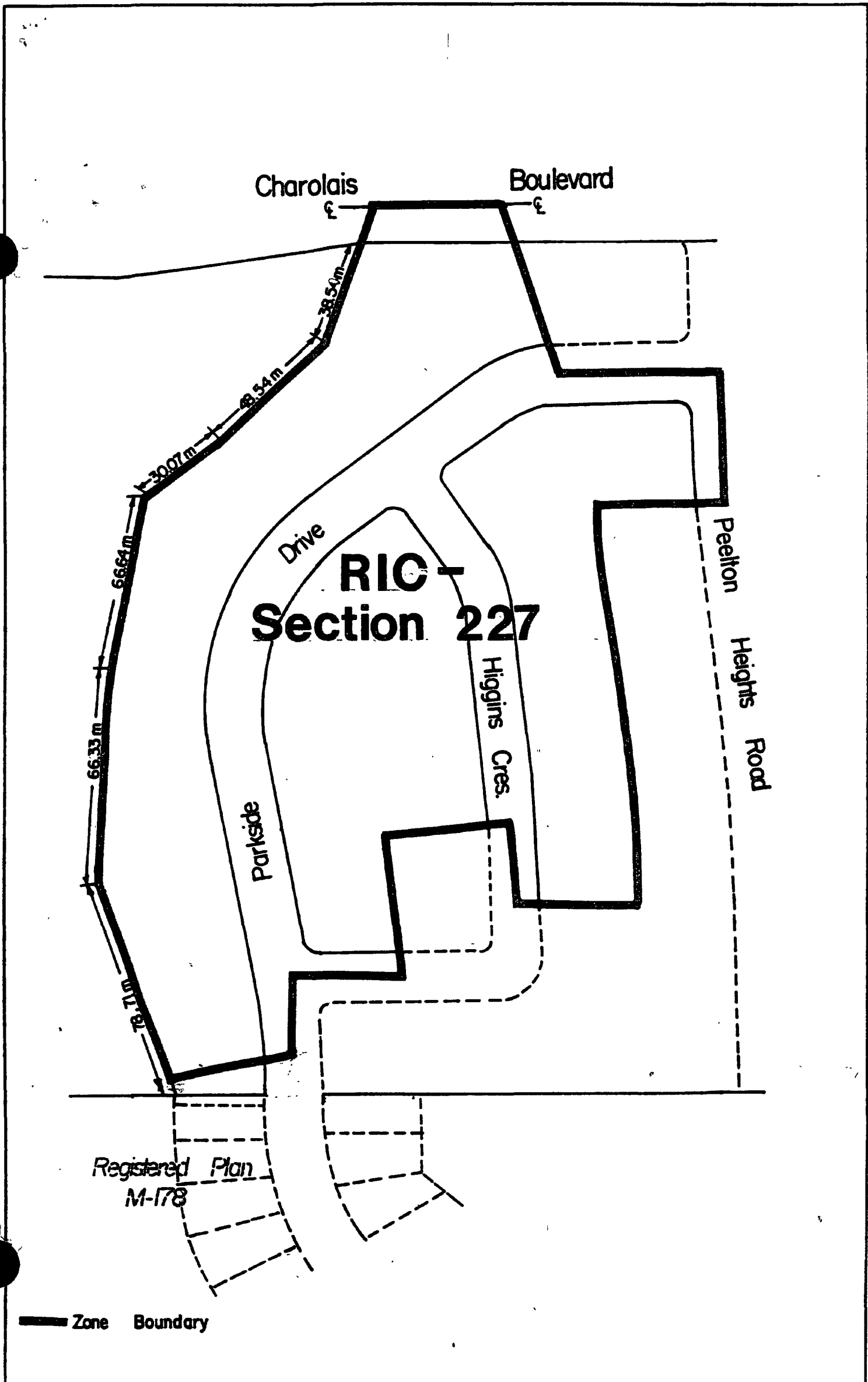

PART LOT 1, CONCESSION 1 W.H.S.

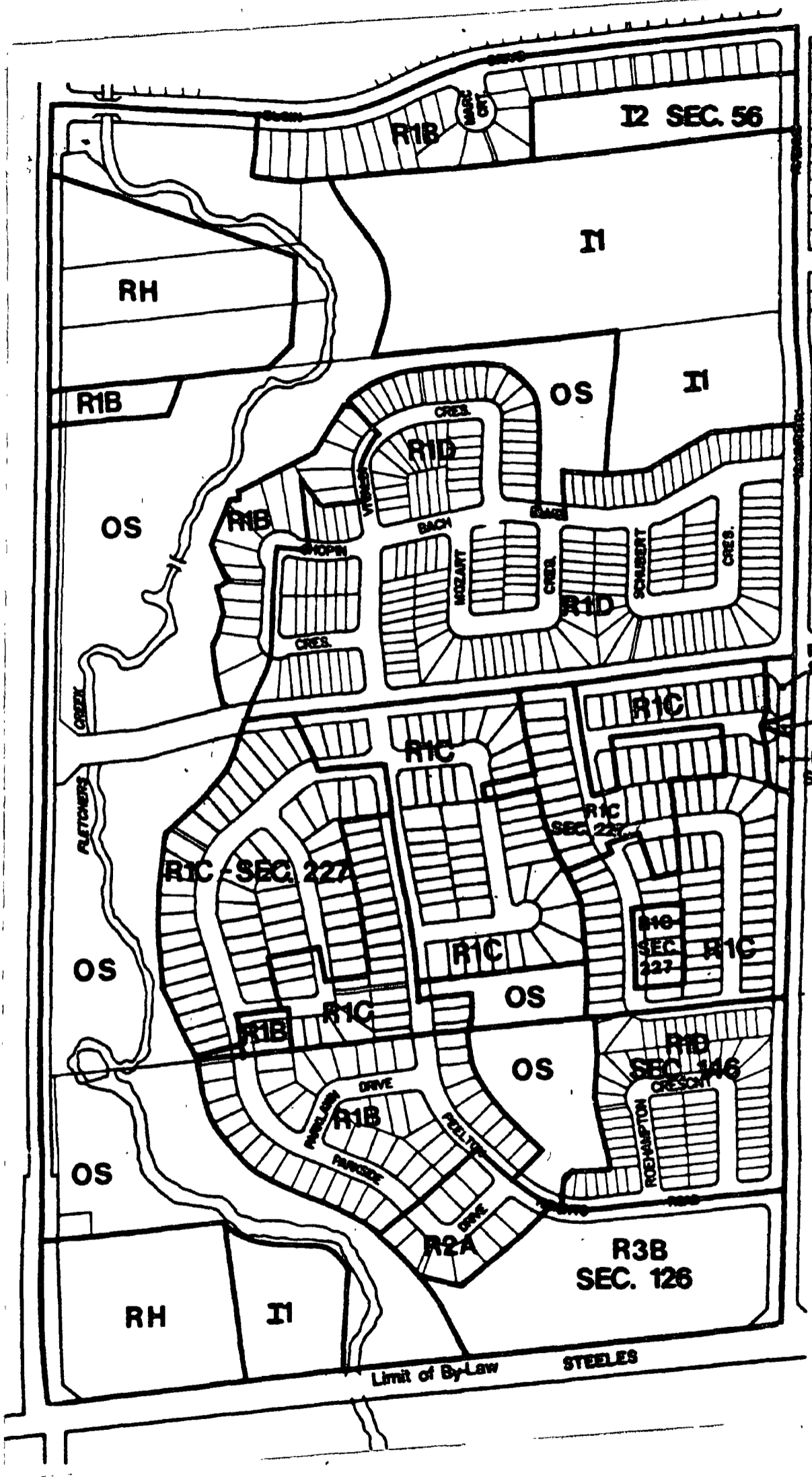

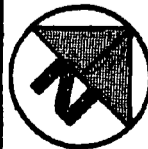
