# BY-LAW

*Number 243-2013*

To amend Municipal Officials By-law 84-2008, as amended,  
and Purchasing By-law 35-2012 to reflect the new organization  
structure of the City of Brampton, effective September 11, 2013

WHEREAS By-law 84-2008 provides for the appointment of officials of the Corporation of the City of Brampton;

WHEREAS By-law 35-2012 provides the City's authorities for procurement; and

WHEREAS the new organization structure of the City becomes effective on September 11, 2013;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


1. That By-law 84-2008 is hereby amended by deleting clauses 3, 4, 5, 6, 7, and 8, and by inserting the following new clauses:
  3. That Marilyn Ball be appointed as Chief, Planning and Infrastructure Services Officer, assuming responsibilities of the positions formerly known as Commissioner of Planning, Design and Development, Commissioner of Community Services, and Commissioner of Works and Transportation.
  4. That Peter Simmons be appointed as Chief, Corporate Services Officer, assuming responsibilities of the positions formerly known as Commissioner of Corporate Services and Commissioner of Financial and Information Services.
  5. That Dennis Cutajar be appointed as Chief Operating Officer, assuming responsibilities of the positions formerly known as Commissioner of Economic Development and Communications and Commissioner of Community Services.
  6. That Julian Patteson be appointed as Chief, Public Services Officer, assuming responsibilities of the positions formerly known as Commissioner of Buildings and Property Management, Commissioner of Community Services, Commissioner of Financial and Information Services, and Commissioner of Works and Transportation.



  - b) That Shirley Gannon be appointed as Deputy Treasurer.
  - c) That Roman Parzei is hereby delegated all of the powers and duties of the Treasurer with respect to the collection of taxes.
2. That Purchasing By-law 35-2012 be amended to reflect the new organization structure, as follows:
  - a) Schedule "F" is hereby deleted and replaced with the updated Schedule "F", as attached.
3. That this by-law is effective September 11, 2013
