



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 244-76

A By-law to amend By-law Number 861 as amended by By-law Number 877 as amended, and as amended by By-law Number 249-75 as amended by By-law Number 94-76

The Municipal Council of the Corporation of the City of Brampton ENACTS as follows:

- 1) By-law 861 as amended by By-law 877 as amended be further amended by adding to Section 3, Sub-sections 2 and 3, zone classification known as Residential Multiple RMIC Special.
- 2) No person shall within a Residential Multiple RMIC Special Zone, erect or use any building or structure or use any land, in whole or in part, for any purpose other than in accordance with the provisions of a Residential Multiple RMIC Zone with the exception that the maximum density shall be 15 dwelling units per acre.
- 3) By-law Number 249-75 as amended by By-law Number 94-76 amending By-law Number 877 as amended, be further amended by adding a new section between Sections 8 and 9 of By-law Number 249-75 as amended as follows:

8A
No person shall within a Residential Multiple RMIC Special Zone, erect or use any building or structure or use any land, in whole or in part, for any purpose other than in accordance with the provisions of the Zone.
- 4) That part of Schedule 'A' of By-law Number 249-75 as amended by By-law Number 94-76 which relates to the lands outlined in a heavy broken line on Schedule 'A' hereto attached shall be amended by changing the zone designation from RMIC to the zone designation shown.


- 5) This By-law shall not come into force unless and until approved by the Ontario Municipal Board.

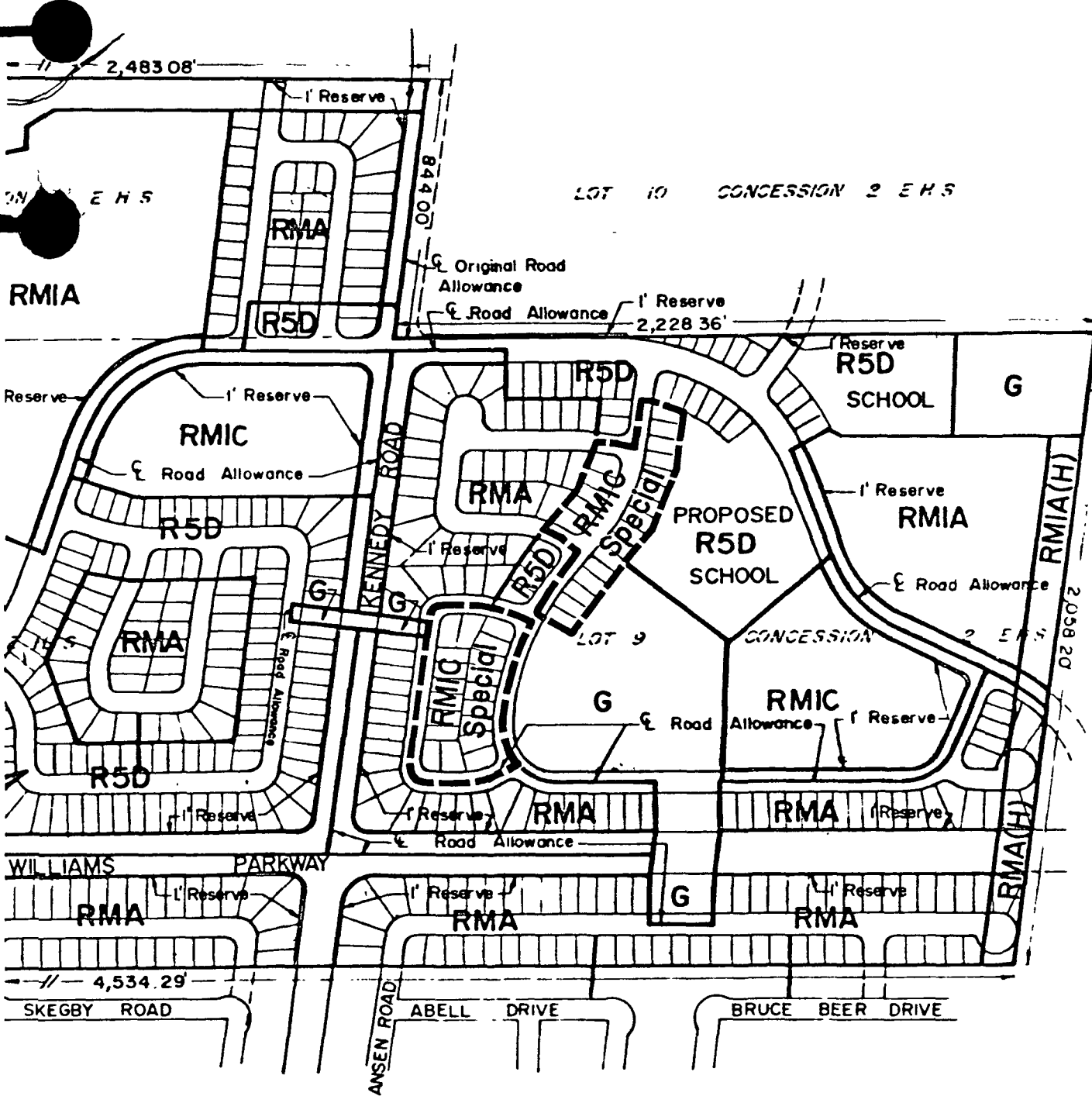

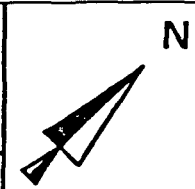

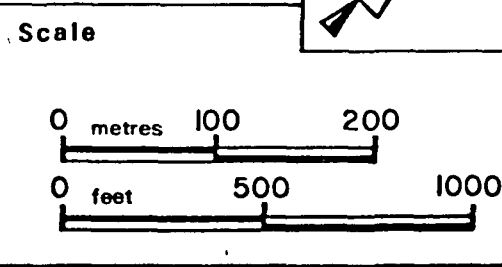
