To authorize the expropriation of certain lands in the City of Brampton

WHEREAS it is the intention of The Corporation of the City of Brampton, as expropriating authority to expropriate the lands described in Schedule A hereto for the purposes of constructing a public highway to create an intersection with Main Street North and Nelson Street West, which would eliminate the need for a portion of California Street;

NOW THEREFORE The Council of The Corporation of the City of Brampton hereby ENACTS AS FOLLOWS:

- 1. The expropriation of the lands described in Schedule A hereto for the purposes of a public highway is hereby authorized.
- The Clerk is hereby authorized to make application on behalf of The Corporation of the City of Brampton, to the Council of The Corporation of the City of Brampton as approving authority, to approve the said expropriation.
- 3. The Clerk is hereby authorized to sign all notices and advertisements on behalf of The Corporation of the City of Brampton as required by the Expropriations Act, (R.S.O. 1980, c. 148, as amended) in respect of the said expropriation.
