# BY-LAW

Number 246-92

To authorize the transfer of part of  
Lot 12, Concession 2, East of  
Hurontario Street to the Peel Board  
of Education

The Council of The Corporation of the City of Brampton hereby ENACTS as follows:

1. The transfer of those parts of the east half of Lot 12, Concession 2, East of Hurontario Street, described as Parts 10, 11, and 12 on reference plan 43R-19390 to the Peel Board of Education, in exchange for a transfer of part of the east half of Lot 12, Concession 2, East of Hurontario Street, described as Parts 1 to 6 (both inclusive) on reference plan 43R-19413 is hereby authorized.
2. The Mayor and Clerk are authorized to execute all of the documents approved by the City Solicitor that are necessary to effect the transfer of the said lands.


