The Council of The Corporation of the City of Brampton ENACTS as follows:

The Mayor and the Clerk are hereby authorized to execute an agreement dated October 14th, 1981 between Public Technology Inc. and The Corporation of the City of Brampton relating to PTI Fire Station Location Package, and all other documents approved by the City Solicitor required to implement the provisions of this agreement.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 14th day of October, 1981.

THIS CONTRACT, entered by and between The Corporation of The City of BRAMPTON, ONTARIO and PUBLIC TECHNOLOGY, INC., (PTI), WITNESSES:

τ.

PTI agrees to provide the City of Brampton the PTI Fire Station Location Package. In connection therewith, PTI shall assist the City of Brampton in implementing the package and shall provide the following:

- A. a complete set of procedural manuals, including data collection forms;
- B. technical assistance from trained PTI staff, on-site, in Brampton, to be provided through a maximum of three site visits that will include up to a maximum of five days on site, and other indirect assistance from its Washington office;
- C. technical assistance from trained PTI staff in training of all local personnel to be involved in the project, installation of computer programs, and interpreting and presenting results of the project.
- D. a computer tape containing the complete set of computer programs required for the project which shall become the property of the City upon receipt thereof;
- E. technical assistance from PTI computer experts in installing, modifying and operating all computer programs associated with the project;
- F. technical assistance in interpreting all results; and
- G. assistance, if needed, in presenting results to elected officials, citizen's groups, etc.

I-A.

The interpretation and execution of this contract governed by the Laws of the Province of Ontario.

II.

In consideration for the materials and services to be provided to the City of Brampton by PTI as set out in paragraph 1 hereof, the City agrees to pay PTI the sum of seven thousand five hundred U.S. dollars (\$7,500 U.S.) in two installations as follows:

90% at the start of the project (\$6,750 U.S.) and 10% at the completion of the project (\$750 U.S.) which for purposes of this contract shall consist of preparation of a final report with recommendations for presentation to the Chief Administrative Officer.

III.

Term of this contract shall be one year from date of its execution or until PTI has completed its obligations under this contract, whichever is later, and may be renewed for a one year period upon the expressed written request of the City.

IV.

Site visits by PTI in excess of the number specified in paragraph I. shall be made only upon written request of the City and shall be reimbursed at the rate of three hundred fifty U.S. dollars (\$350 U.S.) per day plus travel expenses.
