- (3) Appendix A-3 is deleted and replaced by a revised Appendix A-3, attached hereto as Schedule "B".
- (4) The attached Schedule "C" is hereby added as Section 6.8.

### **SECTION 6.8 - EMERGENCY TELECOMMUNICATIONS COORDINATOR**

**SUBSECTION 6.8.1.** - Once a state of emergency is declared in the City of Brampton, the Emergency Telecommunications Coordinator will be responsible for and perform the following duties as directed by the Head of Council or his/her designate.

- **6.8.1.1.** Attend at the Emergency Operations Centre if activated to provide emergency internal telephone communications within the city offices and the EOC as required; and to provide a public inquiry service.
- **6.8.1.2.** Request the assistance of Peel A.R.E.S. (Amateur Radio Emergency Services) in providing emergency and backup telecommunications links between the EOC and any other locations as required.
- **6.8.1.3. -** With the City Clerk and Manager, ensure that the emergency public inquiry centre is properly equiped and working and, correct any problems that may arise.
- **6.8.1.4. -** Request additional communications resources required during an emergency, egs. portable radios, cellular telephones, etc.
- **6.8.1.5.** Ensure through Bell Canada that Line Load Control has been activated when requested by the Control Group.
- **6.8.1.6.** Maintain logs and prepare post emergency reports.
