



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 250-94

To amend By-law 151-88, as amended

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:
 - (1) by changing on Sheet 6C of Schedule 'A' thereto, the zoning designations of the lands shown outlined on Schedule 'A' to this by-law from RESIDENTIAL SINGLE FAMILY C (HOLDING) - SECTION 506 (R1C(H) - SECTION 506), RESIDENTIAL SINGLE FAMILY D (HOLDING) - SECTION 508 (R1D(H) - SECTION 508), RESIDENTIAL STREET TOWNHOUSE B (HOLDING) - SECTION 510 (R3B(H) - SECTION 510), RESIDENTIAL SINGLE FAMILY C (HOLDING) - SECTION 511 (R1C(H) - SECTION 511), and RESIDENTIAL SINGLE FAMILY D (HOLDING) - SECTION 512 (R1D(H) - SECTION 512) to RESIDENTIAL SINGLE FAMILY C - SECTION 506 (R1C - SECTION 506), RESIDENTIAL SINGLE FAMILY D - SECTION 508 (R1D - SECTION 508), RESIDENTIAL STREET TOWNHOUSE B - SECTION 510 (R3B - SECTION 510), RESIDENTIAL SINGLE FAMILY C - SECTION 511 (R1C - SECTION 511), and RESIDENTIAL SINGLE FAMILY D - SECTION 512 (R1D - SECTION 512).
 - (2) by deleting from the first line of section 506 the word "(HOLDING)".
 - (3) by deleting therefrom section 506.2(2).
 - (4) by deleting from the first line of section 508 the word "(HOLDING)".

- (5) by deleting therefrom section 508.2(2).
- (6) by deleting from the first line of section 510 the word "(HOLDING)".
- (7) by deleting therefrom section 510.2(6).
- (8) by deleting from the first line of section 511 the symbol "(H)".
- (9) by deleting therefrom, section 511.2 and substituting therefor the following:

"511.2 shall be subject to the requirements and restrictions relating to the R1C zone, and all the general provisions of this by-law."

- (10) by deleting from the first line of section 512 the symbol "(H)".
- (11) by deleting therefrom, sections 512.2 and 512.3 and substituting therefor the following:

"512.2 shall be subject to the requirements and restrictions relating to the R1D zone, and all the general provisions of this by-law."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 28th day of November, 1994 .



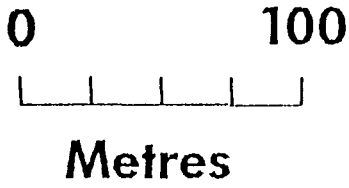

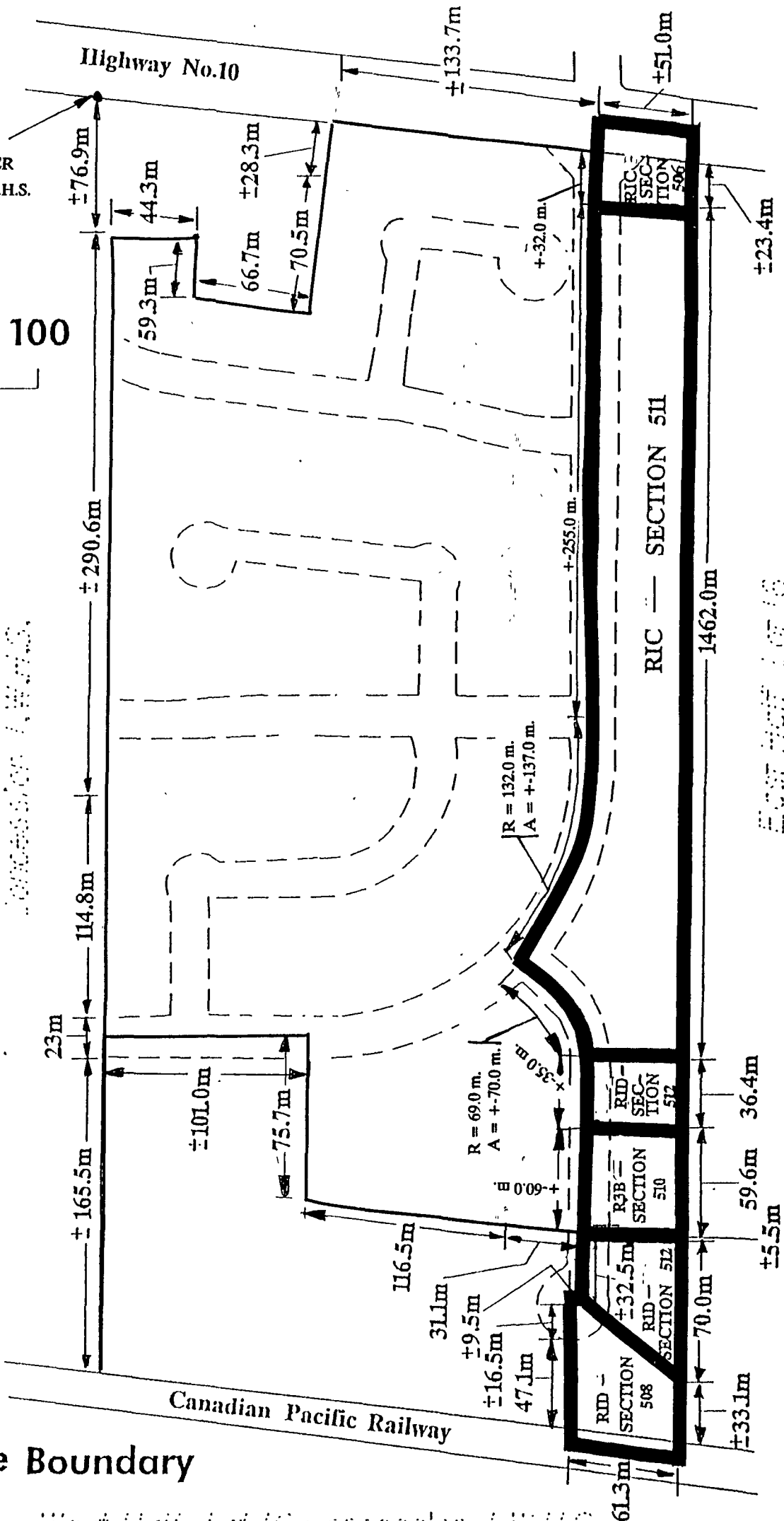
West Half Lot 16, Concession 1, E.H.S.

Concession 1, W.H.S.

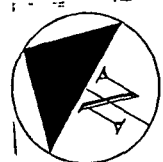
East Half Lot 16
