BY-LAW

Number 253-93

To amend By-law 200-82, as amended, (part of
Lot 4, Concession 1, W.H.S., in the former
Town of Brampton)

The council of The Corporation of the City of Brampton

ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

(1) by changing on Sheet 20 of Schedule A thereto, the land use designation of the lands shown outlined on Schedule A to this by-law, from INSTITUTIONAL ONE (I1) and RESIDENTIAL HAMLET (RH), to INSTITUTIONAL ONE - SECTION 381 (I1 - SECTION 381);

(2) by adding thereto the following section:

"381 The lands designated I1 - Section 381 on Sheet 20 of Schedule A to this by-law

381.1 shall only be used for the following purposes:

(a) the purposes permitted in an I1 zone by section 40.1.1.

381.2 shall be subject to the following requirements and restrictions:


- (1) Minimum interior side yard width - 1.7 metres;
- (2) Minimum rear yard depth - 3.0 metres.

381.3 shall also be subject to the requirements and restrictions of the I1 zone, and the general provisions of this by-law not in conflict with those set out in section 381.2."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 8th day of November 19 93

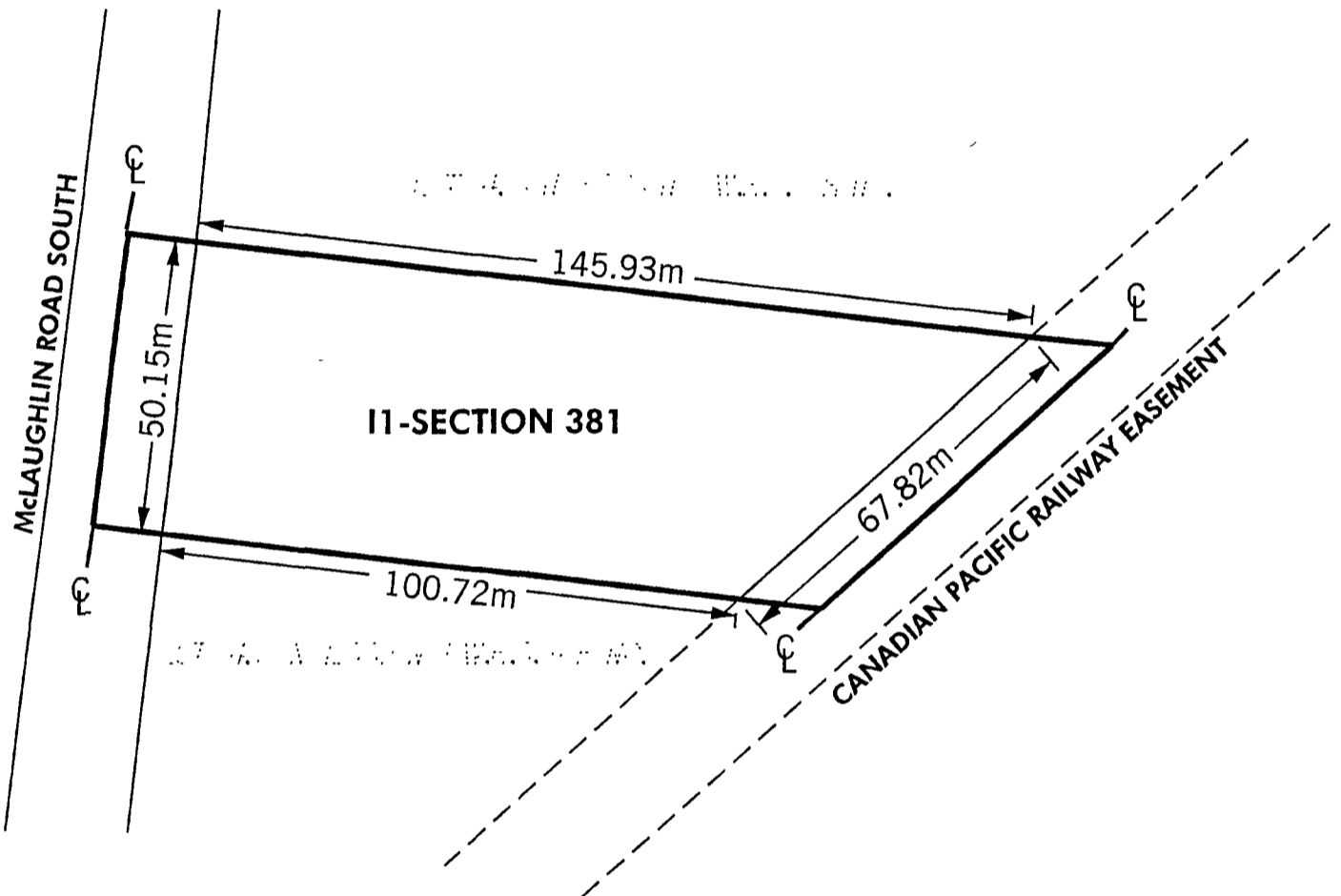

- m METRES

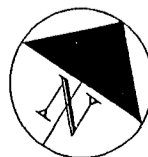


