WHEREAS it is deemed expedient in the interest of The Corporation of the City of Brampton that the part of Union Street described in Schedule A to this by-law be stopped up and closed and that the sale or lease of the said lands be authorized;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four consecutive weeks in the Brampton Guardian, a newspaper published in the City of Brampton;

AND WHEREAS the said Corporation has given notice to The Regional Municipality of Peel, pursuant to Section 44 of the Regional Municipalities Act (R.S.O. 1990, c.R.8, as amended) and The Regional Municipality of Peel has indicated that it does not object to such stopping up;

AND WHEREAS the Council for the said Corporation has heard in person or by counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- The part of Union Street described in Schedule A on this by-law is hereby stopped up and closed.
- 2. The sale or lease of the said lands is hereby authorized. The intended purchaser or lessee and the purchase price or rent to be charged shall be determined by a subsequent by-law of Council.
- 3. The affidavit of Leonard J. Mikulich attached as Schedule B to this by-law forms part of this by-law.

READ a FIRST, SECOND, and THIRD TIME, and PASSED in open Council this 12th day of December, 1994.

SCHEDULE B TO BY-LAW 256-94 AFFIDAVIT OF LEONARD J. MIKULICH

- 1. I am employed as City Clerk The Corporation of the City of Brampton and as such, I have knowledge of the facts herein contained.
- 2. Notice of the intention of the Council of The Corporation of the City of Brampton to pass a by-law stopping up and closing and authorizing the sale or lease of the part of Union Street according to Plan BR-2 designated as Part 7 on Plan 43R-20623 was published in the Brampton Guardian on the dates listed below:
