BY-LAW

Number 263-86

To amend By-law 200-82, as
amended.
(8 Flowertown Avenue)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

- (1) by changing, on Sheet 2 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from COMMERCIAL ONE - (C1) to COMMERCIAL ONE - SECTION 272, (C1 - SECTION 272), such lands being part of Lot 7, Concession 2, W.H.S., in the geographic Township of Chinguacousy.
- (2) by adding thereto, as SCHEDULE C-SECTION 272, Schedule B to this by-law,
- (3) by adding to section 3.2, thereof, as a plan to be included in Schedule C, the following:

"Schedule C - Section 272"

- (4) by adding thereto, the following section:

"272. The lands designated C1-Section 272 on Sheet 2 of Schedule A to this by-law:

272.1 shall only be used for the following purposes:

- (1) the purposes permitted by section 21.1.1, and
- (2) a dry cleaning plant and laundry establishment.


272.2 shall be subject to the following requirements and restrictions:

- (1) the dry cleaning plant and laundry establishment shall be located within the area shown as Unit Area on Schedule C - Section 272, and
- (2) the dry cleaning plant and laundry establishment shall use only non-toxic non-flammable materials.

272.3 shall also be subject to the requirements and restrictions relating to the C1 zone and all the general provisions of this by-law, which are not in conflict with the ones set out in section 272.2.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,

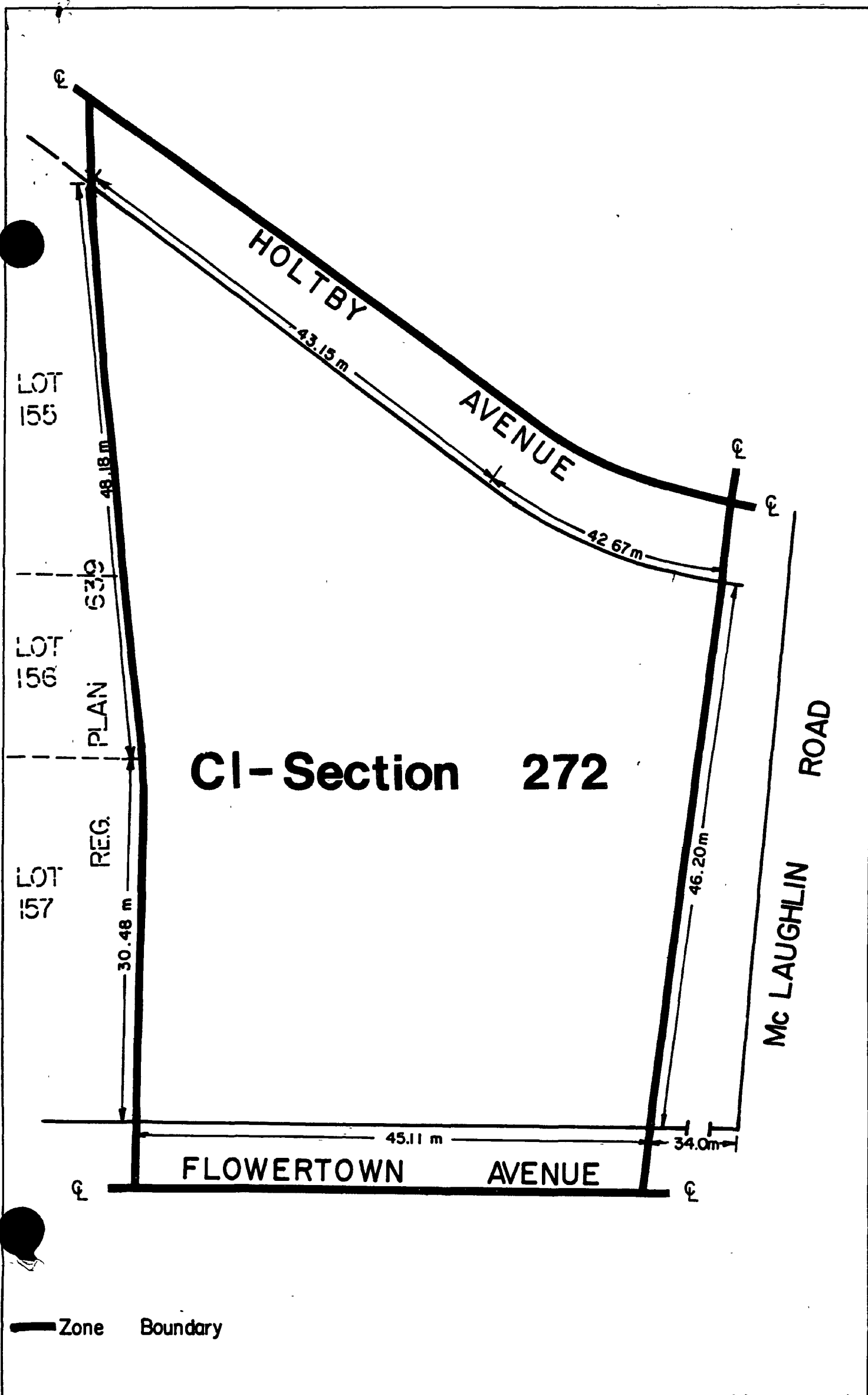

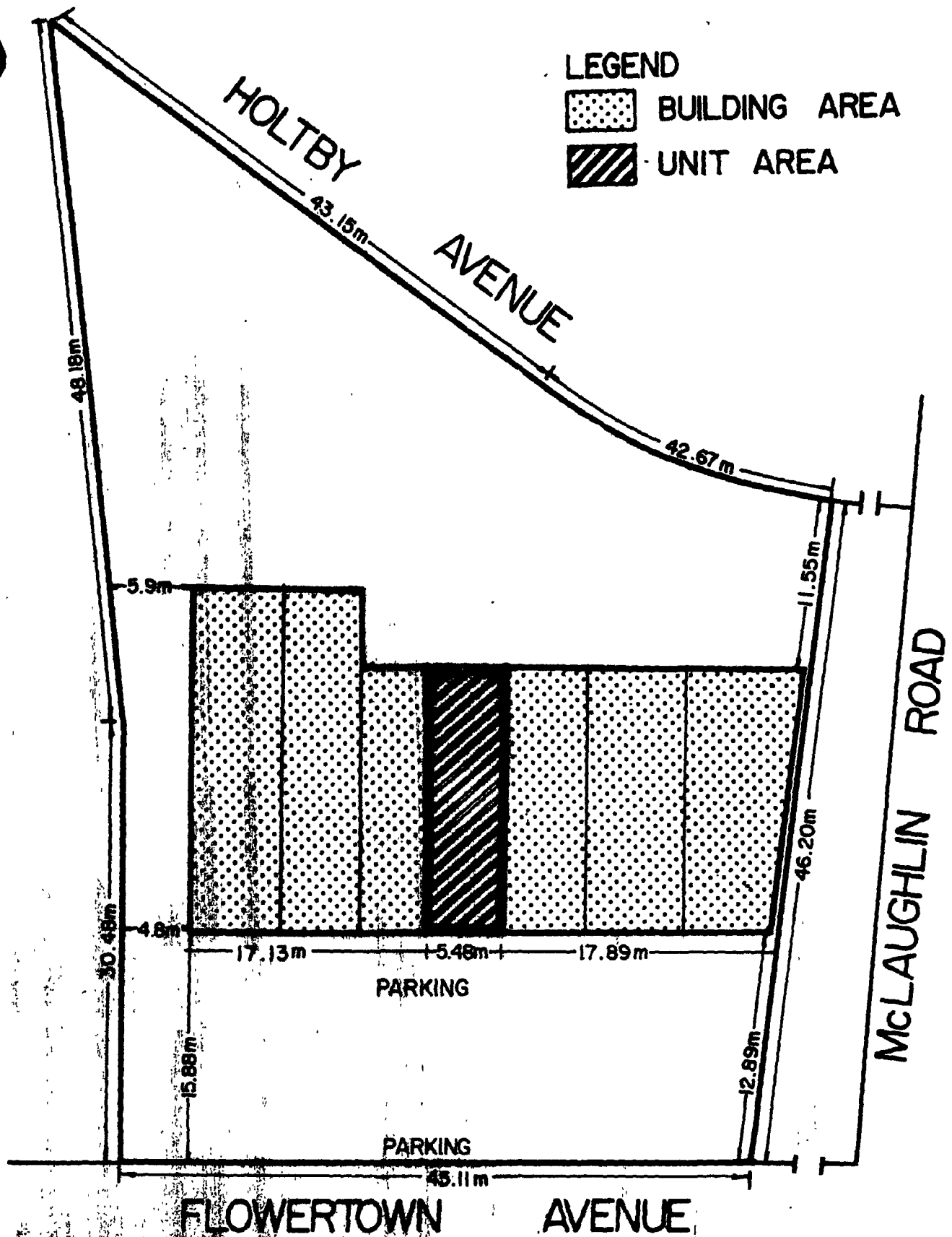
