- b) In Section 16 after the word "inspections" the words, "licenses, permits" shall be added.
- 2. Anywhere in the by-law where the words "Fire Department" is found "Fire & Emergency Services Department" will be read in its place.
- 3. Schedule A-1 is hereby deleted and replaced with a revised Schedule A-1 attached as Schedule I to this by-law.
- 4. Schedule A-2 is hereby deleted and replaced with a revised Schedule A-2 attached as Schedule II to this by-law.
- 5. By-laws 278-93 and 119-94 are hereby repealed.
