SCHEDULE A to By-law No. ~~262-97~~

I THE FOLLOWING LANDS ARE ESTABLISHED AS MARKET SQUARE BOULEVARD

1. Part of Lots 46, 47, 48, and 49, and Part of Nelson Street (Unopened)  
Registered Plan BR-2
2. Part of Lots 1, G, H, and I, and Part of Ann Street (Closed)  
Registered Plan BR-3
3. Part of California Street (Closed)  
Registered Plans BR-3 and 541
4. Part of Block A, part of the service road (Closed), and Part of unlabeled parcel of land east of the Service Road,  
Registered Plan 541
5. Part of Lots 5, 6, and 7,  
Registered Plan BR-2

All of which are designated as Parts 1, 3, 4, 5, 6, 7, and 44 on reference plan 43R-22128

II THE FOLLOWING LANDS ARE ESTABLISHED AS PART OF EAST SERVICE ROAD

Part of Block A, Registered Plan 541

Designated as that part of Part 51, reference plan 43R-22128, adjoining the northerly limit of East Service Road shown on Registered Plan 541.

III THE FOLLOWING LANDS ARE ESTABLISHED AS PART OF HANNAH STREET

1. Part of Block A, Registered Plan 541
2. Part of Lots 8 and 10, Registered Plan BR-10
3. Part of California Street (Closed) Registered Plan BR-10
4. Part of Lots 46 and 47, Registered Plan BR-2

All of which are designated as Parts 51 and 52, on reference plan 43R-22128, save and accept that part of Part 51, reference plan 43R-22128 adjoining the northerly limit of East Service Road shown on Registered Plan 541.
