RATE OF SPEED - KILOMETRES/HOUR
North Park Drive

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 193-83, as amended, is hereby further amended:

(1) by adding to the specified columns of Schedule XVI thereto the following items:

RATE OF SPEED - KILOMETRES/HOUR

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN
North Park Drive	40	A point 259 metres north of Williams Parkway and a point 705 metres north of Williams Parkway
North Park Drive	40	A point 932 metres north of Williams Parkway and a point 1346 metres north of Williams Parkway

This by-law shall not come into force until approved by the council of The Regional Municipality of Peel.
