**To amend By-law 93-93,
RATE OF SPEED, DESIGNATED TURNING LANES
FIRE ROUTES**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule X thereto the following item:

RATE OF SPEED

| COLUMN 1 HIGHWAY | COLUMN 2 RATE OF SPEED | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|--------------------------|---------------------------|---|--|
| McLaughlin Road South | 40 | 10 metres north of Corona Gate to a point 240 metres north of Harold Street | 8:00 a.m. to 5:00 p.m. on school days |

(2) by adding to Schedule VI thereto the following items:

DESIGNATED TURNING LANES

| COLUMN 1 HIGHWAY | COLUMN 2 BETWEEN | COLUMN 3 LANE | COLUMN 4 DIRECTION | COLUMN 5 COMPULSARY TURN |
|--------------------------|---|------------------|-----------------------|--------------------------------|
| Rutherford Road North | Williams Parkway and Carl Dali Court | Right Lane | Northbound | Right Turn |

(3) by deleting from Schedule XV thereto the following item:

NO STOPPING

| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|---------------------|------------------|--|---------------------------|
| Intermodal Drive | North | Airport Road and Midair Court (extended) | Anytime |
| Intermodal Drive | South | Airport Road and Devon Road (extended) | Anytime |

(4) by adding to Schedule XV thereto the following item:

NO STOPPING


| COLUMN 1 HIGHWAY | COLUMN 2 SIDE | COLUMN 3 BETWEEN | COLUMN 4 TIMES OR DAYS |
|---------------------|------------------|--|---------------------------|
| Intermodal Drive | Both | Airport Road and a point 280 metres east of Midair Court | Anytime |
| Clark Boulevard | Both | Airport Road to the easterly limit of Clark Boulevard | Anytime |

(5) by adding to Schedule XXII thereto the following items:


