**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to THROUGH HIGHWAYS (Schedule III) and
STOP SIGNS (Schedule IV)**

The Council of the Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

THROUGH HIGHWAYS

COLUMN 1
HIGHWAY

COLUMN 2
BETWEEN

Mountainberry Road	The east limit of Mountainash Road (northerly intersection) and the east limit of Mountainash Road (southerly intersection)
Midsummer Drive	The east limit of the intersection of Midsummer Drive with itself and the north limit of Cottrelle Boulevard
Mount Royal Circle	The south limit of Eiffel Boulevard and the south limit of Lacoste Boulevard

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

COLUMN 1

COLUMN 2
BETWEEN

Mountainberry Road	The east limit of Mountainash Road (northerly intersection) and the east limit of Mount Ranier Crescent (westerly intersection)
Mountainberry Road	The east limit of Mountainash Road (southerly intersection) and the west limit of Mount Ranier Crescent (westerly intersection)
Mount Royal Circle	The south limit of Eiffel Boulevard and the east limit of Landscape Drive

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:
