BY-LAW

Number 271-2003

To amend By-law 93-93,

ONE-WAY TRAFFIC, THROUGH HIGHWAYS, STOP SIGNS, PROHIBITED TURNS, NO PARKING

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule I thereto the following items:

ONE WAY TRAFFIC

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN	COLUMN 3 DIRECTION
Theatre Lane	Market Square Blvd (northerly intersection) and Market Square Blvd (southerly intersection)	Southbound and Eastbound

(2) by deleting from Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Market Square Boulevard	The east limit of Main Street North and the north limit of Queen Street East

(3) by adding to Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Market Square Boulevard	The east limit of Main Street North and the east limit of Theatre Lane

(4) by adding to Schedule IV thereto the following items:

STOP SIGNS

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
Market Square Boulevard and Union Street	Westbound on Union Street
Market Square Boulevard and Union Street	Southbound on Market Square Boulevard
Market Square Boulevard and Union Street	Northbound on Market Square Boulevard
Market Square Boulevard and Theatre Lane	Eastbound on Theatre Lane

(5) by adding to Schedule VII thereto the following item:

PROHIBITED TURNS

COLUMN 1 HIGHWAY	COLUMN 2 DIRECTION	COLUMN 3 TURNS PROHIBITED	COLUMN 4 TIMES OR DAYS
Market Square Boulevard and Theatre Lane (southerly intersection)	Northbound	Left	Anytime

(6) by deleting from Schedule XIV thereto the following item:

NO PARKING


COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Theatre Lane	East	Market Square Boulevard and a point 39 metres south of Market Square Boulevard	Anytime
Theatre Lane	East and North	A point 39 metres south of Market Square Boulevard and a point 158 metres south	6:00 am to 6:00 pm Monday to Friday
Theatre Lane	West and South	Market Square Boulevard and the east limit of the road (including cul-de-sac)	Anytime

(7) by adding to Schedule XIV thereto the following item:

NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Theatre Lane	Both	Market Square Boulevard (northerly intersection) and Market Square Boulevard (southerly intersection)	Anytime
