# BY-LAW

Number -277-86

To amend By-law 200-82

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

(1) by deleting section 1.1 thereof, and substituting therefor the following:

"1.1 This by-law applies to those lands within the boundaries of the former Town of Brampton which are shown outlined on Schedule A to this by-law, and to certain lands within the boundaries of the former Township of Chinguacousy which are shown outlined on Schedule A to this by-law."

(2) by deleting the first two lines of section 1.2 thereof, and substituting therefor the following:

"1.2 The by-laws of the former Town of Brampton and of the City of Brampton set out below no longer apply to the lands within the boundaries of the former Town of Brampton to which this by-law applies:"

(3) by adding thereto, after section 1.2, the following section:

"1.3 The by-law of the former Township of Chinguacousy and of the City of Brampton set out below no longer applies to those lands within the former Township of Chinguacousy to which this by-law applies:

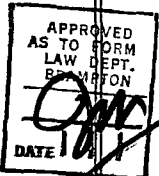




DECLARATION
